2001 BAC Spooktacular Open WI Sanction #2001-99

- DATE: Sunday, October 21, 2001
- LOCATION: Middleton-Cross Plains High School Pool 2230 Bristol Avenue Middleton, WI 53562
- FACILITY: An 8-lane, 25-yard pool with a starting depth of 4-1/2 to 5 feet and a turn depth of 4 feet. It has regulation-height starting blocks (30") and ample viewing area for athletes and spectators.
- CLASSIFICATION: A-B-BB-C
- SCHEDULE: Morning session warm-ups will be 8:00-9:00am. The meet will start promptly at 9:05am. Afternoon session warm-ups will begin at the conclusion of the morning session and last for one hour. Schedule will be posted at <u>www.badgeraquatics.com</u> once all entries are in.
- WARM-UPS: First 20 minutes will be general warm-up/circle swim. Sprint and pace lanes will be designated during the final 40 minutes at the discretion of the meet directors.
- ENTRIES: Swimmers may compete in four (4) individual events per day plus relays. Entries will be accepted up to a maximum of 1600 entries for the meet. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries in the Hy-Tek commlink format.
- ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no later than **Friday**, **October 12**, **2001**. No entries will be taken over the phone. However, email entries are encouraged and can be sent to seversen@facstaff.wisc.edu. Unless you have received a confirmatory email from the above address, it has not been received! Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline.
- ENTRY FEES: \$1.25 LSC splash fee per swimmer, \$3.00 per individual event and \$12.00 per relay.
- DECK SEEDING & COACHES may deck-seed swimmers to the limit of filling heats. Entries will not be allowed to exceed meet entry limits and all deck entries must be completed 30 minutes prior to the start of the session. Decision to grant entry is up to the meet director. There will be a surcharge of \$10 plus entry fees for anyone wishing to be deck seeded. Deck USA Swimming Registrations will not be accepted.

- TIMING SYSTEM: All events (with the exception of 25-yard races) will be timed using a Colorado Timing System with horn start, touch pads, one button, and two watches as backup. 25-yard races will be timed with two (2) stopwatches.
- ADAPTIVE Please indicate on the entries form any special needs for those athletes swimmers: requiring assistance. Also, please inform the head official of those needs prior to the start of the meet.
- AWARDS: 1st through 16th place ribbons will be awarded for individual events and relays. Heat winners will also be awarded for 12 & under individual events.

SCORING: This meet will be scored through 16th place, with relays scoring double.

- OFFICIALS: Rich Hubbard
- MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.
- ADMISSIONS: Free admission for each session. Programs will be available for \$5.00.
- FINAL RESULTS: Each participating club shall receive one hardcopy of final meet results. Teams that submitted their entries via email need to bring a disk to receive results at the immediate conclusion of the meet. Commlinked meet results will be sent via email upon request.
- CONCESSIONS: Delicious hot and cold foods will be available for purchase throughout the meet.
