

2001 BAC Single Age Meet WI Sanction #2001-100

- DATE: Sunday, November 11, 2001
- LOCATION: Edgewood High School
2219 Monroe Street
Madison, WI 53711
- FACILITY: A 6-lane, 25-yard pool with a starting depth of 10 feet and a turn depth of 3 feet. It has regulation-height starting blocks (28") and ample viewing area for athletes and spectators.
- CLASSIFICATION: A-B-BB-C using 6&U, 7, 8, 9, 10, 11, 12, 13, and 14 year-old age groups.
- SCHEDULE: Sunday A.M. warm-ups 7:30am
meet start 8:35am
Sunday P.M. warm-ups at the conclusion of the A.M. session and
lasting 45 minutes.

Schedule will be posted at www.badgeraquatics.com once all entries are in.

- WARM-UPS: General warm-up/circle swim: First half of warm-ups session.
Sprint and pace lanes: Second half of warm-ups session with lanes designated at the meet directors' discretion.
- ENTRIES: Swimmers may compete in four (4) individual events per day plus relays. Entries will be accepted up to a maximum of 1200 entries for the meet. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries on disk in the Hy-Tek commlink format.
- ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no later than **Friday, November 2, 2001**. No entries will be taken over the phone. However, email entries are encouraged and can be sent to seversen@facstaff.wisc.edu. Unless you have received a confirmatory email from the above address, it has not been received! Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline.
- ENTRY FEES: \$1.25 LSC splash fee per swimmer, \$2.00 per individual event and \$8.00 per relay.
- DECK SEEDING & REGISTRATION: COACHES may deck-seed swimmers to the limit of filling heats. Entries will not be allowed to exceed meet entry limits and all deck entries must be completed 30 minutes prior to the start of the session. Decision to grant entry is up to the meet director. There will be a surcharge of \$10 plus entry fees for anyone wishing to be deck seeded. Deck USA Swimming Registrations will not be accepted.

- TIMING SYSTEM:** All events (with the exception of 25 yard races) will be timed using a Colorado Timing System with horn start, touch pads, one button, and two watches as backup. 25-yard races will be timed with two stopwatches.
- ADAPTIVE SWIMMERS:** Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs prior to the start of the meet.
- AWARDS:** 1st through 6th place ribbons will be awarded to both individual and relay events. Heat winner ribbons will also be awarded.
- SCORING:** This meet will be scored 1st through 6th place, with relays counting double.
- OFFICIALS:** Rich Hubbard
- MEET CONDUCT:** Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.
- ADMISSIONS:** Free admission for each session. Programs will be available for \$3.00 per session or \$5.00 for the day.
- FINAL RESULTS:** Each participating club shall receive one hardcopy of final meet results. Teams that submitted their entries via email need to bring a disk to receive results at the immediate conclusion of the meet. Commlinked meet results will be sent via email upon request.
- CONCESSIONS:** Delicious hot and cold foods will be available for purchase throughout the meet.
