

## 2002 BAC Superbowl Splash WI Sanction #2002-12

- DATE: January 18-19, 2002
- LOCATION: Edgewood High School  
2219 Monroe Street  
Madison, WI 53711
- FACILITY: A 6-lane, 25-yard pool with a starting depth of 10 feet and a turn depth of 3 feet. It has regulation-height starting blocks (28") and ample viewing area for athletes and spectators.
- CLASSIFICATION: A-B-BB-C
- SCHEDULE: Friday evening warm-ups 5:30-6:30pm  
meet start 6:35pm  
Saturday warm-ups 9:00-10:00am  
meet start 10:05am  
Schedule will be posted at [www.badgeraquatics.com](http://www.badgeraquatics.com) once all entries are in.
- WARM-UPS: General warm-ups/circle swimming for approximately 30 minutes. One-way sprint, 8 & Under, and/or pace lanes will be designated as needed by the meet director for the remainder of the warm-ups session.
- ENTRIES: Swimmers may compete in TWO individual events on Friday and FOUR individual events on Saturday plus relays. Total entries will be limited to 1200 per day. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries in the Hy-Tek commlink format. The entire Saturday session will be limited to 700 swims!
- ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no later than **Friday, January 4, 2002**. No entries will be taken over the phone. However, email entries are encouraged and can be sent to [seversen@facstaff.wisc.edu](mailto:seversen@facstaff.wisc.edu) (unless you have received a confirmatory email from the above address, it has not been received!). Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline.
- ENTRY FEES: \$1.25 LSC splash fee per swimmer, \$2.00 per individual event and \$8.00 per relay.
- DECK SEEDING & REGISTRATION: There will be deck seeding to the limit of filling heats. Entries will not be allowed to exceed meet entry limits and all deck entries must be completed 30 minutes prior to the start of the session. Decision to grant entry is up to the meet director. There will be a surcharge of \$10 plus entry fees for anyone wishing to be deck seeded. Deck USA Swimming Registrations will not be accepted.

- TIMING SYSTEM:** All events will be timed using a Colorado Timing System with horn start, touch pads, one button, and 2 watches as backup.
- ADAPTIVE SWIMMERS:** Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs prior to the start of the meet.
- AWARDS:** 1<sup>st</sup> through 3<sup>rd</sup> place medals will be awarded to both individual and relay events. 4<sup>th</sup> through 12<sup>th</sup> place ribbons will be awarded for individual events only. Heat winner ribbons will also be awarded for all 12 & under individual events.
- SCORING:** This meet will be scored, but no awards will be given.
- OFFICIALS:** Rich Hubbard
- MEET CONDUCT:** Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.
- ADMISSIONS:** Free admission for each session. Programs will be available for \$1 on Friday evening and \$3 on Saturday.
- FINAL RESULTS:** Each participating club shall receive one hardcopy of final meet results. Teams that submitted their entries via email need to bring a disk to receive results at the immediate conclusion of the meet, OR commlinked meet results will be sent via email upon request. Please include email on Entry Recap for this option.
- CONCESSIONS:** Delicious hot and cold foods will be available for purchase throughout the meet.
