- DATE: October 22-23, 2004
- LOCATION: Middleton-Cross Plains Area Indoor Pool
- FACILITY: An 8-lane, 25-yard pool with a starting depth of 4½-5 feet and a turn depth of 4 feet. It has regulation-height starting blocks (30") and ample viewing area for athletes and spectators.
- CLASSIFICATION: Friday – Senior with Qualifying Times
Saturday - A-B-BB-C using 6&U, 7, 8, 9, 10, 11, 12, 13, and 14 year-old age groups.

- Schedule will be posted at www.badgeraquatics.com once all entries are in.
- WARM-UPS: General warm-up/circle swim: First half of warm-ups session.
Sprint and pace lanes: Second half of warm-ups session with lanes designated at the meet directors' discretion.
- ENTRIES: Swimmers may compete in four (4) individual events per day plus relays. Entries will be accepted up to a maximum of 400 swims for Friday night and 1600 entries for Saturday. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries on disk in the Hy-Tek commlink format. You can download a meet setup file (zipped) from the BAC web site at badgeraquatics.com Friday night heats and events may be combined.
- PROOF OF TIME: Swimmers entering Friday night Senior events must have Coaches use the proof of time button on the meet entry report on team manager.
- ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no later than **Wednesday, October 13th**. No entries will be taken over the phone. Entries via email are encouraged by the deadline. Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline. Entries may be emailed to baclub@badgeraquatics.com on or before the entry deadline.
- ENTRY FEES: \$2.00 LSC splash fee per swimmer, \$3.00 per individual event and \$12.00 per relay.
- DECK SEEDING & REGISTRATION: COACHES may deck-seed swimmers to the limit of filling heats. Entries will not be allowed to exceed meet entry limits and all deck entries must be completed 30 minutes prior to the start of the session. Decision to grant entry is up to the meet director. There will be a surcharge of \$10 plus entry fees for anyone wishing to be deck seeded. All swimmers must currently be registered with USA Swimming. Deck USA Swimming Registrations will not be accepted.
- TIMING SYSTEM: All events (with the exception of 25 yard races) will be timed using a Colorado Timing System with horn start, touch pads, one button, and two watches as backup. 25-yard races will be timed with two stopwatches.
- ADAPTIVE Please indicate on the entries form any special needs for those athletes

- SWIMMERS:** requiring assistance. Also, please inform the head official of those needs prior to the start of the meet.
- AWARDS:** 1st through 8th place ribbons will be awarded to both individual and relay events. Heat winner ribbons will also be awarded for 10 and under.
- OFFICIALS:** Rich Hubbard plus at least two others.
- RULES:** This meet will be conducted under USA Swimming 2003 and Wisconsin Rules.
- MEET CONDUCT:** Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.
- ADMISSIONS:** Free admission for each session. Programs will be available for \$4.00 per session or \$7.00 for the day.
- FINAL RESULTS:** Each participating club shall receive one hardcopy of final meet results. Teams that submitted their entries via email need to bring a disk to receive results at the immediate conclusion of the meet. Commlink meet results will be sent via email upon request.
- CONCESSIONS:** Delicious hot and cold foods will be available for purchase throughout the meet.
