SEEDING: The 400 IM will be run slowest to fastest, girls then boys, as printed in the heat

sheet, with no penalty for a "no shows".

The 1000 Free will be a positive check-in event and will be run fastest to slowest, alternating girls and boys heats. The host team reserves the right to limit the 1000 free to four heats TOTAL for time constraints but will inform teams of their decision at least four days before the meet. The Wisconsin Scratch Rule will apply. Each age

group will be run to completion prior to the start of the next age group and incomplete heats may be combined. Deadline is set for the completion of the 10-

Under 200 IM (event 2).

WARM-UPS: General warm-ups/circle swimming for the first 20 minutes. One-way sprint and/or

pace lanes will be designated as needed by the meet director during the remainder of the warm-up session. The diving well will be available for warm-up/warm-down

during Friday evening and during Saturday & Sunday's afternoon sessions.

ENTRIES: Swimmers may compete in 4 (four) individual events per day plus relays. Total

entries will be limited to a maximum of 1600 per day. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries in the Hy-Tek commlink format. You can download a meet setup file (zipped) from the BAC web

site at badgeraquatics.com

ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no

later than **Wednesday, November 23rd, 2005**. No entries will be taken over the phone. Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline. Entries may be emailed to on or before the entry deadline.

ENTRY FEES: \$2.00 LSC splash fee per swimmer, \$3.50 per individual event and \$12.00 per relay.

DECK SEEDING & REGISTRATION:

<u>COACHES</u> may deck-seed swimmers to the limit of filling heats. Entries will not be allowed to exceed meet entry limits and all deck entries must be completed 30 minutes prior to the start of the session. Decision to grant entry is up to the meet director. There will be a surcharge of \$10 plus entry fees for anyone wishing to be deck seeded. Deck USA Swimming Registrations will not be accepted.

TIMING SYSTEM:

All events (with the exception of 25-yard races) will be timed using a Colorado Timing System with horn start, touch pads, one button, and 2 watches as backup. All 25-yard races will be timed with 2 watches.

ADAPTIVE SWIMMERS:

Please indicate on the waiver form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs prior to the start of

the meet.

AWARDS: 1st through 16th place ribbons will be awarded for individual events. 1st through 3rd

place ribbons will be awarded for relay events. Heat winner ribbons will also be

awarded during 10 & under individual events.

SCORING: This meet will be scored. Points will be awarded 1st through 16th place with relays

counting double. Team High Point trophies will be awarded to 1st through 3rd place.

OFFICIALS: There will be at least three certified USA Swimming Officials on deck at all times.

Head Referee is Ben Radloff.

RULES: This meet will be conducted under 2003 USA and Wisconsin Swimming rules.

MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the

opinion of the Meet Director or Meet Marshall, is harmful to others or to other's

property will be required to leave the competition.

ADMISSIONS: A \$2.00 admission for each session. Programs will be available for \$4.00 per session

or \$7.00 per day.

FINAL RESULTS: Each participating club shall receive one hardcopy of final meet results.
