



director. **NO DECK ENTRIES WILL BE DONE AFTER THE DEADLINE.** There will be a surcharge of \$3.75 plus entry fees = (\$7.50) for anyone wishing to be deck seeded. All swimmers must currently be registered with USA Swimming. **Deck USA Swimming Registrations will be accepted with a \$15.00 handling fee added to the USA Registration fee.**

- CHECK-IN: Swimmers in the **1000 Free** must **check in by 5:30 PM**; events 1 and 2 heats may be combined.
- TIMING SYSTEM: All events will be timed using a Colorado Timing System with horn start, touch pads, one button, and two watches as backup.
- DISABILITY SWIMMERS: Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs **prior** to the start of the meet.
- AWARDS: **There will be no awards for the Friday night Senior races.**
- OFFICIALS: There will be at least three certified USA Swimming Officials on deck at all times. Head Referee is Ben Radloff.
- RULES: This meet will be conducted under USA Swimming 2008 and Wisconsin Rules.
- MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.

- ADMISSIONS: \$2.00 per session admission for 12-older for the session.  
Programs will be available for \$4.00 for the session.
