Brown Deer, WI 53209
- Facility:** Schroeder is 8 lane, 50-meter indoor pool with non-turbulent lane lines and backstroke flags. The starting depth is 7' and the height of the blocks is 30 inches. A fully automated Timing System with touch pads and automatic backup as well as two (2) manual backup watches for each lane will be used. This meet will be fully computerized.
- Eligibility:** All swimmers must be registered with USA Swimming and their USAS numbers must appear on the entry information. Out of state entrants must bring their USAS cards and be prepared to show them to the Clerk of Course. Age as of Friday, June 1, 2007 will be used. Coaches must present a current coaching card before receiving packet!
- Entry Limits:** All swimmers may enter a total of three (3) individual events plus relays each day of the meet.
- Deck Entries/Registration:** Deck entries will be accepted at the discretion of the meet director, and must be accompanied by a payment of \$5.00 per individual event or \$10.00 per relay. Deck registration will be allowed if accompanied by a check for \$58.00 payable to Wisconsin Swimming, Inc.
- Final Results:** All teams will receive final results within two weeks of the completion of the meet. Any extra copies that may be required can be ordered at the admissions table for \$7.00.
- Officials:** To be determined.
- Timing:** All events will be timed finals. Please submit correct METER seed times.
- Entry Fees:** \$4.50 per individual event and \$10.00 per relay plus \$2 Splash Fee per swimmer.
- Deadline:** Reservation checks will be accepted for individual events. Entries, Recap of Entries and Waiver for the meet must be received by **Tuesday, May 15, 2007** if submitted on paper, or **Tuesday May 22, 2007** if submitted on diskette. Late entries will not be accepted. *Please note*, money used for reservations is *not refundable* and cannot be used to offset relay fees. Submit entries to:

- Entry Forms:** This meet is computerized. **Do not submit entry cards.** The host club will provide all cards. All entries must be submitted either on an entry form or on a Hytek Team Manager diskette. Please name the meet MM060107. The meet events can be downloaded from the Wisconsin Swimming website at <http://www.wisconsinswimming.org>. The enclosed Recap of Entries Statement must be completed and the Waiver form signed. These must be returned together with the entry information and your check. Please submit the originals and save the copies for your records.
- Awards:** Each class, A, BB, B-C, will receive medals for placement 1-3 and ribbons for placement 4-6 for age groups 9-10, 11-12, 13-14. 8 and under swimmers will swim with 9-10 year olds, but will be awarded separately. 8 and under swimmers are awarded as one class. 8 and under will be awarded medals for placement 1-3 and ribbons for placement 4-12. Seniors will be awarded as one class for placement 1-3 medals will be received, for placement 4-6 ribbons will be received. Relay ribbons will be awarded to places 1-3 for all age groups.
- Admissions:** Admission charge for spectators will be \$4.00 for anyone 12 and over. Heat sheets will be available for \$3.00 per session. Friday admissions will be \$4.00 with a heat sheet included
- Concessions:** Our concession stand will feature a wide selection of food and beverages. We will also be providing a great selection of food on Friday night. Hot coffee and fresh donuts will be for sale upon morning arrival.
- Conduct:** All teams will be responsible for the conduct of their own swimmers. The meet marshals and meet director shall have the authority to disqualify swimmers for misconduct. **Smoking is not permitted on Schroeder grounds!** This rule will be strictly enforced.
- Hospitality:** If available, there will be a hospitality room next to the secondary pool off the west entrance. All meals and refreshments will be provided to the coaches and officials.
- Adaptive Swimmer:** Please notify the Meet Director as to any special needs for an adaptive swimmer.
- Times:** FRIDAY: General warm-up 4:30-5:30 p.m. Meet starts at 5:40 p.m.
SATURDAY: General warm-up 8:00 a.m. – 9:00 a.m. The afternoon warm-ups will start as soon as the morning session has been completed and will last 45 minutes.
SUNDAY: General warm-up 7:00 a.m. – 8:00 a.m. The afternoon warm-ups will start as soon as the morning session has been completed and will last 45 minutes. The approximate session start times may be found on the web site after May 31st at: <http://www.wisconsinswimming.org>.
- Warm-ups:** All swimmers must enter the pool **FEET FIRST!** All session warm-ups will start circle swim all lanes. Sprint lanes will be added as needed. All sprints must exit opposite end of pool. Any violation or misconduct may result in a disqualification of the swimmer's next individual event.
- Seeding:** The meet will be pre-seeded except for Friday events 5 through 12, which will require positive check-in. **EVENTS 1 - 12 WILL BE LIMITED TO THE TOP 24 SEED TIMES.** The number of entries and time restrictions will determine limits. The events will be scheduled so that all swims will be done by approximately 9:00 p.m. If time permits, additional swims will be added. Refunds will be issued for swimmers who do not get to swim on Friday.
