**Facility:** Schroeder is 8 lane, 50-meter indoor pool with non-turbulent lane lines and backstroke

flags. The starting depth is 7' and the height of the blocks is 30 inches. A fully automated Timing System with touch pads and automatic backup as well as two (2) manual backup

watches for each lane will be used. This meet will be fully computerized.

Eligibility: All swimmers must be registered with USA-Swimming and their USA-S numbers must

appear on the entry information. Out of state entrants must bring their USA-S cards and be prepared to show them to the Clerk of Course. Age as of Friday, May 30, 2008 will be

**Entry Limits:** All swimmers may enter a total of three (3) individual events each day of the meet.

**Deck Entries/Registration:** Deck entries will be accepted at the discretion of the meet director, and must be

accompanied by a payment of \$5.00 per individual event or \$10.00 per relay.

**Timing:** All events will be timed finals. Please submit correct METER seed times.

Awards:

Each class, A,BB,B-C, will receive medals for placement 1-3 and ribbons for placement 4-6 for age groups 9-10, 11-12, 13-14. 8 and under swimmers will swim with 9-10 year olds, but will be awarded separately. 8 and under swimmers are awarded as one class. 8 and under will be awarded medals for placement 1-3 and ribbons for placement 4-12. 13-14 year olds will swim with Seniors, but will be awarded separately. Seniors will be awarded as one class for placement 1-3 medals will be received, for placement 4-6 ribbons will be received.

Admissions:

Admission charge for spectators will be \$4.00 for anyone 12 and over. Heat sheets will be available for \$3.00 per session. Friday admissions will be \$4.00 with a heat sheet included.

**Concessions:** 

Our concession stand will feature a wide selection of food and beverages. We will also be providing a great selection of food on Friday night. Hot coffee and fresh donuts will be for sale upon morning arrival.

Conduct:

All teams will be responsible for the conduct of their own swimmers. The meet marshals and meet director shall have the authority to disqualify swimmers for misconduct. **Smoking is not permitted on Schroeder grounds!** This rule will be strictly enforced. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

The number of entries and time restrictions will determine limits. The events will be scheduled so that all swims will be done by approximately 9:00 p.m. If time permits, additional swims will be added. Refunds will be issued for swimmers who do not get to swim on Friday.
