- Facility:** Lake Andrea is a lake with depths from 0 to 30 feet. A fully automated Timing System with timing chips will be used. This meet will be fully computerized.
- Eligibility:** All swimmers 14 years and younger must be registered with USA Swimming and their USA-S numbers must appear on the entry information. Out of state entrants must bring their USA-S cards and be prepared to show them to the Clerk of Course. Age as of Saturday, June 28, 2008 will be used.
- Entry Limits:** All swimmers may enter one (1) event.
- Final Results:** Final results will be posted to [www.wisconsinswimming.org](http://www.wisconsinswimming.org) and [www.kenoshabarracudas.com](http://www.kenoshabarracudas.com).
- Officials:** Head Official – Kim Thompson
- Timing:** All events will be timed finals.
- Entry Fees:** The entry fee is \$40 if registered before June 14th, 2008. After June 14<sup>th</sup> the entry fee for the event is \$45. Event will take place rain or shine. No refunds.
- Deadline:** The deadline for pre-registration is June 14th, 2008.
- Entry Forms:** Registration forms will be available at [www.wisconsinswimming.org](http://www.wisconsinswimming.org) and [www.active.com](http://www.active.com)
- Awards:** All non-wetsuit events, except the ½ Mile Masters, will be award a trophy for first place, second and third place medals and finishers medals. Wetsuit events do not apply to USA-S swimmers.
- Admissions:** There is no admission charge.
- Concessions:** Our concession stand will feature a wide selection of food and beverages

- Conduct:** All swimmers will be responsible for their own conduct. The meet marshals and meet director shall have the authority to disqualify swimmers for misconduct. Course cutting is a disqualifiable infraction.
- Disabled Swimmer:** Please notify the Meet Director as to any special needs for an adaptive swimmer.
- Warm-ups:** There will be no in-water warm-ups.
- Open Events:** There are no open events. All swimmers must enter into their age group event as indicated in the event list.
- Aquathon:** The aquathon is a 1-mile swim and a 5K run.
- Course Setup:** The course will be set-up and measured via GPS. The competitive course will be triangular and measured 1-Mile from start to finish. The 500 yard and ½ mile swims will be a separate out and back course.
