LOCATION:	Carthage College Koenitizer Aquatic Center 1700 Sheridan Rd. Kenosha, WI 53140
FACILITY:	Indoor, twenty-five (25) yard pool with 10 lanes with non-turbulent lane lines. Pool depth at both ends seven (7) feet. An additional 6 lanes for warm-ups and cool down will be available throughout the entire meet. The block height is 30 inches.
TIMING SYSTEM:	A fully automatic timing system will be used with a manual backup button plus 2 backup timers for each lane. A horn start will be used to start all events, should the automatic system fail, a backup starting device will be used.
ELIGIBILITY:	All swimmers must be currently registered with United States Swimming and their USA-S numbers must appear on the entry form. Out of state deck entrants must bring their USA-S cards and be prepared to show them to Clerk of Course. Age as of Friday, November 21 st , 2008 will be used. Coaches must present a current coaching card before receiving packet.
ENTRY LIMITS:	All swimmers may enter a total of four (4) individual events plus relays each day of the meet.
DECK ENTRIES/ REGISTRATION	Deck entries will be accepted at the discretion of the meet director, and must be accompanied by a payment of \$5 per individual event, \$15.00 per relay. Deck registration will be allowed if accompanied by a check for \$60.00 payable to Wisconsin Swimming, Inc.
FINAL RESULTS:	All teams will receive final results and they will be posted to the Wisconsin Swimming web site (<u>http://wisconsinswimming.org</u>) within one week of the completion of the meet. Any extra copies that may be required can be ordered at the admissions table for \$7.00.
OFFICIALS:	To be determined. Head official is Kim Thompson from the Kenosha Barracuda Swim Team. If your team plans to participate and you have officials who might like to officiate the meet, Kim Thompson can be reached at 262-857-3838.
TIMING:	All events will be timed finals. Please submit correct YARD seed times.
ENTRY FEES:	\$4.25 per individual event and \$12.00 per relay plus \$3 Splash Fee per swimmer.

RESERVATION:	Reservations will be accepted on a first come, first serve basis determined by the postmark (not before September 9 th , 2008 for Wisconsin teams and September 16 th , 2008 for out of state teams.)
DEADLINE:	Reservation checks will be accepted for individual events. Entries, Recap of Entries and Waiver forms for the meet must be received by 11/05/2008 if submitted on paper or by 11/12/2008 if submitted on diskette, or by e- mail Late entries will not be accepted. Please note, money used for reservations is nonrefundable and cannot be used to offset relay, deck seeding fees or splash fees. ENTRY FORMS:	This meet is computerized. Do not submit entry cards. The host club will provide all relay cards. All entries must be submitted either on the enclosed entry form or on a Hytek Team Manager diskette. The sanctioned meet events can be downloaded from the Wisconsin Swimming website at: <u>http://wisconsinswimming.org</u> . The enclosed Recap of Entries Statement must be completed and the Waiver form signed. These must be returned together with the entry forms (diskette) and your check. Please submit the originals and save the copies for your records. In order to insure accurate times and names, please PRINT clearly.
AWARDS:	Each class, A,BB,B-C, will receive medals for placement 1-3 and ribbons for placement 4-6 for 10 & under, 11-12, 13-14. 8 and under will be awarded as one class for placement 1-3 medals will be received, for placement 4-12 ribbons will be received. Seniors will be awarded as one class for placement 1-3 medals will be received, for placement 4-6 ribbons will be received. Relay ribbons will be awarded to places 1-3 for all age groups.
ADMISSIONS:	Admission charge for spectators will be \$3.00 per day for anyone 12 and over. Heat sheets will be available for \$3.00 per session. Friday night admission and heat sheet is \$3.00.
