WARM-UPS: The first 30 minutes of each warm-up session is circle swimming only, no diving from

the starting blocks. The next 30 minutes: Lanes 2, 3, 4, and 5 sprints (one directional swimming from starting end only, diving from the blocks permitted). Lanes 1 and 6 circle swimming. Meet Marshals will be on deck during the entire warm-up, with

authority to recommend disqualification from individual events.
