swimmers must hold current 2009 USA Swimming registration. Relays: First and last names of competing swimmers and order of swimming must be listed on

relay card along with age, prior to swimming the relay. No Recall Starts.

WARM-UPS: Sit and Slide entries from the starting end of the pool during general warm-

ups will be enforced for all sanctioned/approved competition.

The first 30 minutes of each warm-up session is circle swimming only, no diving from the starting blocks. The next 30 minutes: Lanes 2, 3, 4, and 5 sprints (one directional swimming from starting end only, diving from the blocks permitted). Lanes 1 and 6 circle swimming. Meet Marshals will be on deck during the entire warm-up, with authority to recommend disqualification from individual events. Meet management

reserves the right to assign warm-up lanes.

ENTRIES: Completed entry forms, signed waiver, and fees must be received by Friday, **January 2**,

<u>2009</u>. Preferred method of entry is by diskette in HY-TEK COMMLINK format. You can download a meet setup file (zipped) from the WI web site.
