- Date: Saturday, January 15, 2005
- Location: Brookfield East High School

Brookfield, WI 53005
- Facility: Six (6) lanes, 25 yard indoor pool, backstroke flags, non-turbulent lane dividers, 3.5 feet minimum depth. Height of blocks is 30 inches. Depth of pool at starting blocks is 12 feet. Timing will be with 3 manual watches per lane for 25 yard events. All other events will use Colorado electronic timing system with touch pads and two-watch back-up per lane.
- Eligibility: Official 2005 Short Course rules shall prevail at this meet. Swimmers must be registered Wisconsin USS swimmers. Out-of-state entrants must bring a valid USS card and present it at the scorer's table prior to the start of the meet. Coaches acting in a coaching capacity must have passed the required certification test and must display the current membership card.
- Time Schedule: Morning session warm-ups will start at 7:00am. First 30 minutes: general warm-up (circle swim) in lanes 1-6; no diving. Second 30 minutes: continue general warm-up in lanes 1 and 6; 25 yard sprints in lanes 2,3,4 and 5. Meet begins at 8:05am. Afternoon session warm-ups will begin immediately following the conclusion of the morning session. The afternoon session will begin 65 minutes after completion of the morning session.
- Entries: Swimmers are limited to a total of four (4) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Please notify meet officials of any adaptive swimmers upon arriving at the meet. Any special requirements for swimmers should also be noted on the entry forms.
- Entry Fees: Fees are \$3.00 per individual event, \$8.00 per relay. Add \$2.00 LSC Splash Fee per individual swimmer.
- Entry Deadline: Completed entry forms, waiver, and fees must be received by the Meet Director no later than December 23, 2004. Late entries will NOT be accepted. This meet will be run using Hytek Meet Manager software. Hytek disk entries will be accepted and are preferred. Please include hardcopy with all disk entries. Teams who submit entries via disk may pick up their final results disk at the conclusion of the meet. Each participating club shall receive

- Deck Seeding and Registrations: COACHES may deck-seed swimmers to the limit of filling heats. Entries will not be allowed to exceed meet entry limits. Decision to grant entry is up to the Meet Director. There will be a surcharge of \$5.00 plus entry fees for all deck entries. USA swimming registrations will NOT be accepted.
- Officials: Brian Borden, Tim McAvoy, Dave Severance, Curt Paulsen
- Admissions: \$3.00 for all spectators over 12 years of age. Heat Sheet \$2.00. All spectators must remain in designated viewing area; only meet participants and personnel will be allowed on the pool deck.
- Awards: Custom awards for 1st-3rd place in individual events. Ribbons for the 4th – 12th Place finishers in individual events. Ribbons for 1st-6th Place for relay events. Custom awards for those B – C swimmers achieving A or BB times. In keeping with our Hawaiian theme, leis will be awarded to all heat winners.
- Concessions: An outstanding assortment of food and beverages will be available at reasonable prices from the meet kitchen.
