Facility: Five (5) lanes, 50 meter outdoor pool, backstroke flags, non-

turbulent lane dividers, 4 ft. minimum depth. Height of blocks is 18 inches. Depth of pool at starting blocks is 4 feet. Timing on 100 and longer events will be with Colorado electronic timing system with touch pads and two watch back-up per lane. Timing on all 50 meter events will be with three stopwatches per lane.

Eligibility: Official 2005 Long Course rules shall prevail at this meet.

Swimmers must be registered with USA swimming. Out-of-state entrants must bring a valid USS card and present it at the scorer's table prior to the start of the meet. Coaches acting in a coaching capacity must have passed the required certification test and must

display the current membership card.

Time Schedule: Morning session warm-ups will start at 7:00 am. First 30 minutes

general warm-up (circle swim) in lanes 1-8; no diving. Second thirty minutes sprint lanes will be allocated at meet manager's discretion. Meet begins at 8:10 am. Afternoon session warm-ups will begin immediately following the conclusion of the morning session. The afternoon session will begin 65 minutes after completion of the morning session, but not before 11:00 am. Morning session swimmers may warm down in the diving well under supervision of a coach; the diving well is closed during the

pm session of the meet.

Entries: Swimmers are limited to a total of four (4) individual events.

Clubs may enter an unlimited number of relay teams. All entered times must be in meters. This will be a pre-seeded meet. For all events swimmers are expected to be at the blocks, ready to swim, when their events and heats are announced. Please note any

special requirements for swimmers on entry forms.

Distance Event All events will be pre-seeded, except the 400 IM events, (event numbers 25, 26, 27, 28, 53, and 54), which will be deck-seeded,

fastest to slowest. Check-in and scratches are required for these deck-seeded events at the meet office prior to the end of warm-ups. An announcement of the sign-up time limits will be made during warm-ups. If insufficient entries occur, the meet director can

decide to consolidate the boys and girls 400 IM events.
