Second session warm-ups will start immediately following the first session. Second session will begin 65 minutes after completion of the first session. Coaches will be contacted with timeline information as soon as it is available.
Entries: Swimmers are limited to a total of four (4) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. Please notify meet officials of any adaptive swimmers upon arrival at the meet. Any special requirements for swimmers should also be noted on entry forms.
Entry Fees: $\quad$ Fees are $\$ 3.00$ per individual event, $\$ 8.00$ per relay. Add $\$ 2.00$ Splash Fee per individual swimmer.
