Facility: Six lanes, 25 yd indoor pool, backstroke flags, non-turbulent lane dividers, 3.5 feet minimum depth, 30 inch block height with 12 feet depth. The depth of non-starting end requires that the 2nd and 4th legs of 100 yd medley relay start in the water.

Timing: 3 manual watches per lane for 25 yd events

Rules: Official 2008 Short Course USA Swimming and WI Swimming rules shall govern the conduct of this meet. Coaches must display their certification cards while on deck.

Eligibility: Swimmers must be registered USA swimmers. Age is as of June 6, 2008.

Schedule: Warm-ups will run from 5:00 p.m. to 5:50 pm. There will be general warm-up in lanes 1-6 with sit and slide entries only. 25 yd sprints in lanes 2, 3, 4, and 5 to be announced by meet manager. Meet begins at 6:00 p.m.

Entries: Swimmers are limited to a total of four (4) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Please indicate on the entry form any special needs your swimmers may have.

Entry Fees: \$4.00 per individual entry; \$10.00 per relay entry; \$2.00 LSC splash fee
