Lanes 1, 2, & 8 Circle swims
Lanes 3 & Push/Pace
Lanes 4, 5 & 6 One way sprints

The meet starts at 9:15 AM on June 16, 2007
All swimmers must enter the pool feet first during circle swims.
A coach from your team must be on deck during warm-ups.
Swimmers not following warm-up procedures may be Disqualified at the discretion of the Meet Marshall.

Official USS Short Course Rules will be used for this meet

ELIGIBILITY:

All swimmers must be USS registered. Out of state swimmers must show their present USS cards to the Meet Marshall on the day of the meet. Ages as of June 16, 2006. **Swimmers must enter all five events (Free, back, breast, fly and IM)** in his/her age group.

ENTRY DEADLINE LIMITATIONS:

All entries, waivers and fees must be received no later than **June 8th 2007**. Please do not send seed cards. **Entries sent via HY-Tek COM link disk are highly encouraged along with a hard copy**. E-mail is also highly encouraged: dmmiller6019@sbcglobal.net

ENTRY FEES:

Entry fees are **20.00 per swimmer**. Event fees + splash fee.
Entry fees are NON-REFUNDABLE. SWIMMERS PAY FOR ALL FIVE EVENTS, even if they do not intend to compete in 5 events.
Make checks payable to FORT ATKINSON SWIM TEAM.

AWARDS:

Trophies will be given for 1st – 3rd place and **medals** for 4th, 5th, and 6th in each age group (for TOTAL TIME OF ALL 5 EVENTS) all swimmers who compete in the pentathlon, who do not receive a place trophy or medal, will receive a participation award. Places will be determined by the totaled times from all five events. Any swimmer who scratches an event or is disqualified will not be eligible for the 1st – 3rd place trophies or the 4th – 6th place medals, but will be eligible for a participation award if they swim one event or individual event ribbons. INDIVIDUAL RIBBONS for individual events places 1-8 in age groups.

AGE GROUPS:

Swimmers will swim in heats grouped as 8&U, 9-10, 11-12, 13-14, 15 & Over. However awards will be broken into age groups, 7&U, 8,9,10,11,12,13, 14, 15&O.

DECK SEEDING:

Regular event seeding. DECK SEEDING WILL STOP AT 8:30 AM. (45 minutes before the start of the meet). Meet Manager reserves the right to charge a \$10.00 deck seed charge per entry. Deck seed charges must be paid at the time the entry is installed.

GENERAL MEET INFORMATION:

Disabled Swimmers and coaches on the deck must be Registered USAS currently.

One copy of meet results will be mailed to all teams. Additional Copies will be available for \$5.00. If you are entering an disabled Swimmer, please notify the meet referee prior to the start of the meet. Each club will be responsible for the conduct of it's swimmers.
