- FACILITY:** The Menomonee Falls High School pool is a 25- yard pool with 6 lanes, non-turbulence lane markers and backstroke flags. Pool depth is 3'6" to 5'. 30" slanted starting blocks into 5' pool depth in all lanes. Colorado-V automatic timing system will be used with backup buttons and timers for all six lanes. All 25 yards, 8 and under events will be timed manually and start from the blocks.
- MEET TIME:** **Saturday:** Warm-ups: 9:00 a.m. / Meet Starts: 10:05 a.m. **Sunday:** Warm-ups 8:00 am
LINE Meet Starts at 9:05 a.m. The Saturday and Sunday afternoon sessions will not **Start** before 12:00 noon. The Saturday afternoon session warm-ups will begin 5 minutes after the morning session, so that the touch pads may be removed. Tentative timeline for the meet will be available from the meet director on the Monday night prior to the weekend of the meet.
- WARM-UP:** LANES 1 - 6 will be general swimming only for the first 30 minutes of warm-ups.
PROCEDURE The last 30 minutes lanes 3 - 4 will be one way sprints only and 1-2 - 5 - 6 will remain general swimming only. Other lanes may be opened for sprints as needed.

- ENTRY:** Individual Events: \$3.00 / entry; Relay Events: \$8.00 / entry
FEES There is also a Wisconsin Swimming Association Splash Fee of \$1.25 per participating swimmer in the meet. All outstanding fees must accompany entries. Please make all checks payable to: ***Germantown Swim Club***. Team entry will not be accepted without the required entry / waiver forms and entry fees.
- ADMISSIONS:** Spectators (18 years & older) will be charged an admission fee of \$3.00 for each day, Saturday and Sunday. Heat sheets will be available at a fee of \$3.00 for each day, Saturday and Sunday.
- MEET FORMAT:** All events will be pre-seeded, **except events 97 & 98, 11-12, 500 FREE and events 99 & 100, 13-14, 500 FREE, 101 & 102 senior 500 FREE will be deck seeded, fastest to slowest. There will be a limit of 3 heats per gender and age group (top 18 swimmers) for the above mentioned events 97 -102 (500 Free).** Check-in and scratches are required for these deck seeded events at the timing console up to the end of warm-ups. An announcement of the sign-up time limits will be made during warm-ups. Please have all swimmers present at the starting end prior to the start of their events. If insufficient entries occur, the meet director can decide to consolidate the boys and girls 500 FREE events. Swimmers who don't get into the 500 free events can have their entry fee for the event refunded. All Relay events will be pre-seeded, with the swimmers reporting to the respective lane, heat and starting ends that they are seeded within. Coaches will have all relay cards within their team packets. **Names and ages, in order of swimmers and must be on the back of all relay cards, unless relays were pre-seeded and there are no changes.**

All 8 and Under, 25 yard events will be watch timed. BB-B time standards for this meet apply to 14 & Under events. SENIOR events follow USS rule 203.2 Eligibility - All registered swimmers are eligible for the SENIOR class.

NOTE:

ALL WISCONSIN USS RULES ARE IN EFFECT,

- **Effective December 1, 2000, the “No Recall start became official.**
- **Current USS and Wisconsin Swimming Rules shall govern the conduct of this meet.**
- **If there are any Special Needs Swimmers see Management before/ at meet.**
- **All swimmers, coaches and officials must be registered USS members.**

Note: There is **NO SMOKING ALLOWED** within the buildings or on the grounds of Menomonee Falls High School per village and county laws.

ENTRIES:

All entry forms and fees are due no later than January 21st, 2004.

Entries are limited to 1,200 swims per day as stipulated by the Wisconsin Swimming Association Inc. meet reservation policies. Swimmers are limited to (4) individual swims and (1) relay swim on each day for Saturday and Sunday. Age of swimmer is to be determined as of February 7, 2004. Deck entries will be accepted, but limited to the LSC limits and the discretion of the Meet Director. No athlete registrations will be done at the meet unless already entered with the original team entries. This meet will use the Hy-Tek system with its latest updated program. Designated team disks may be used for initial and final results.
