- LOCATION:** Waukesha South High School
401 E. Roberta Drive
Waukesha, WI 53186
- FACILITY:** New 8/10 lane, 25 yard pool, 13 foot starting depth, 30" blocks with non-turbulent lane markers and backstroke flags. The pool features a 12 ½ by 14 ½ foot full color, digital display scoreboard. Colorado System 6 timing system with aqua grip touch pads.
- MEET TIME LINE:** Warm-ups: 8:00 a.m. / Meet Starts: 9:05 a.m. The afternoon session will not start before 11:00 AM. The afternoon session warm-ups will begin 5 minutes after the morning session, so that the touch pads may be removed. A tentative timeline for the meet will be available from the meet director on the Monday night prior to the weekend of the meet.
- WARM-UP: PROCEDURE:** Lanes 1-8 will be general swimming only for the first 30 minutes of warm-ups. The next 20 minutes lanes 3 - 4 – 5 - 6 will be one way sprints only and 1 - 2 and 7 -8 will remain as general swimming only. Other lanes may be opened for sprints as needed.

- ENTRY: FEES** Individual Events: \$3.50 / entry; Relay Events: \$10.00 / entry
There is also a Wisconsin Swimming Association Splash Fee of \$2.00 per participating swimmer in the meet. All outstanding fees must accompany entries. Please make all checks payable to: ***Germantown Swim Club***. Team entry will not be accepted without the required entry / waiver forms and entry fees.
- ADMISSIONS:** Spectators (12 years & older) will be charged an admission fee of \$3.00. Heat sheets will be available at a fee of \$3.00.
- MEET FORMAT:** **All events will be pre-seeded except events 29 & 30, 400 I. M., 61 & 62, 11-12, 200 free, and 63 & 64, 500 free which will be deck seeded fastest to slowest. In the case where the length of the session may exceed the LSC four hour rule, the meet director may limit these deck seeded events to no more than 3 heats per event (24 fastest seeded individuals).** Check-in and scratches are required for these deck seeded events at the timing console/ computer room up to the end of warm-ups in the AM session and up to 30 minutes prior to the end of warm-ups in the PM session. An announcement of the sign-up time limits will be made during warm-ups. Please have all swimmers present at the starting end prior to the start of their events. Swimmers who don't get into the 200 & 500 free and 400 I. M. events can have their entry fee for the event refunded.
- All 10 & U and 11-12 entries/events fall under the A-BB + B-C format. Coaches are responsible for entering 8 & U swimmers in 10 & U events in order to be eligible for the A-BB + B-C format with achiever medals.
- All relay events will be pre-seeded, with the swimmers reporting to the respective lane, heat and starting ends that they are seeded within. Coaches will

have all relay cards within their team packets. **Names, ages, and order of swimmers must be legibly written on the back of all relay cards, unless relays were pre-seeded and there are no changes.**

**MEET FORMAT:

All 8 & U, 25 yard events will be watch timed. BB-B time standards for this meet apply to 12 & U swimmers. SENIOR events follow USS rule 203.2 Eligibility - All registered swimmers are eligible for the SENIOR class.

NOTE:

ALL WISCONSIN USS RULES ARE IN EFFECT,

- **Current USS and Wisconsin Swimming Rules shall govern the conduct of this meet.**
- **If there are any Special Needs Swimmers see Management before/at meet.**
- **All swimmers, coaches and officials must be registered USS members.**
- **Coaches must display their current Coaches Card while on deck.**
- **Out of state entrants must bring current USA Swimming cards.**

There is **NO SMOKING ALLOWED** within the buildings or on the grounds of Waukesha South High School per village and county laws.

Since this meet is classified as an A-BB + B-C meet awards for 1st-16th place are given for the A-BB swimmers and the B-C swimmers ages 12 & U provided they are entered in events classified as 10 & U and 11-12 not 8 & U. However, if a swimmer achieves a BB or better time and was entered with a seed time in the B-C classification, that swimmer receives a medal only and does not receive an award for 1st-16th place in either classification (i.e. A-BB or B-C) because they have just "achieved" the new time standard. The intention is to reward those swimmers who may not finish 1st-16th in the A-BB group but have achieved a significant improvement in their time. See Wisconsin Swimming Policy 5, entitled "Awards" and Policy 6, entitled "Classified Swimming".

ENTRIES:

All entry forms and fees are due absolutely no later than January 20th, 2006.

Entries are limited to 200 swims per lane per day as stipulated by the Wisconsin Swimming Association Inc. meet reservation policies. Swimmers are limited to (4) individual swims and (2) relays swim. Age of swimmer is to be determined as of January 28, 2006. Deck entries will be accepted, but limited to the LSC limits and the discretion of the Meet Director. No athlete registrations will be done at the meet unless already entered with the original team entries. This meet will use the Hy-Tek system with its latest updated program. Designated team disks may be used for initial and final results.
