- FACILITY:** The Walter Schroeder YMCA Aquatic Center pool is an 8 lane, 50 meter indoor pool facility, 6.5 to 17 feet deep with starting blocks at a height of 29.5". A Colorado System-V will be used with back-up buttons and timers for all eight lanes.
- PARKING:** Parking is available in the west parking lot.
- ADMISSIONS:** Spectators (18 & older) will be charged \$3.00 for admission each day. Heat Sheets will cost \$3.00 each.
- MEET TIME LINE:** **Saturday/Sunday A.M. Warm-ups: 8:00 A.M.**  
**Meet Starts: 9:05 A.M.**
- Saturday/Sunday P.M.** The afternoon warm-ups will not begin before 1:00 P.M.
- During warm-ups, lanes 1 – 8 will be general swimming only, for the first 30 minutes. The next 20 minutes lanes 2 - 5 will be one way sprints only, and lanes 1, 6 – 8 will remain general swimming only.

- ENTRIES:** Entries are limited to 1,400 swims per day as stipulated by the Wisconsin Swimming Association Inc. meet reservation policies. Please estimate the number of swimmers by session and make reservations accordingly. Swimmers are limited to (3) individual events and (1) relay event per day. Age of swimmer is to be determined as of May 13<sup>th</sup>, 2006. All swimmers must be currently registered with USA Swimming. **Deck entries will be accepted, but limited to any LSC sanctioning limits and the discretion of the Meet Director. No athlete registrations will be done at the meet.** This meet will use the Hy-Tek™ system/software. An Event File for Team Manager will be posted on line at [www.wisconsinsswimming.org](http://www.wisconsinsswimming.org).
- ENTRY DEADLINE:** The meet director must receive a completed entry from, signed waiver, and fees no later than **Wednesday, May 3<sup>rd</sup>, 2006**. Entries will not be accepted without the required entry / waiver forms and entry fees. Any changes in entries or seeding will be at the discretion of the Meet Director.

- ENTRY FEES:** **Individual Events:** \$4.50/entry  
**Relay Events:** \$12.00/entry

**Wisconsin Swimming Association Splash Fee:** \$2.00 per participating swimmer.  
Please make all checks payable to **GERMANTOWN SEAHAWK SWIM CLUB**.

**MEET FORMAT:** All events will be pre-seeded, except the following deck-seeded events; 13-14 and Senior 200 Back, 13-14 and Senior 200 Breast, 13-14 and Senior 200 Fly, 400 Free and 400 IM events. Scratches and no shows will not be refunded. All 400 meter individual events will run in fastest to slowest heat order alternating girls/boys.

Check-in and scratches are required for these deck-seeded events on event check-in lists on the glass windows outside of the computer room/office until the end of warm-ups. An announcement of the check-in time limits will be made during warm-ups.

The Meet Director reserves the right to limit the number of 400 Free and 400 IM events to no fewer than 3 heats per event and the number of 13-14 and Senior Back, 13-14 and Senior 200 Breast, and 13-14 and Senior 200 Fly events to no fewer than 4 heats per event (assuming sufficient entries). If insufficient entries occur, the meet director can decide to consolidate the girls/boys 400 Free and girls/boys 400 IM events. Swimmers who check-in and don't get into the deck-seeded events can have their entry fee for the event(s) refunded or, at the discretion of the Meet Director and on a first come first serve basis, may request to be deck-seeded into another event with open lane(s) at no additional charge.

All Relay events will be pre-seeded. Coaches will have all relay cards within their team packets. **Names and ages, in order of swimmers, must be on all relay cards. Any changes/corrections must be made on the prior to the event.** Swimmers shall report to the starting end in their respective event, heat, and lane. Swimmers are to turn in their relay cards to the lane timers. (Please have your swimmers report to the starting area when their event is announced.)

**AWARDS:**

<b>Individual Events:</b>	Ribbons	1st – 16th Place
<b>Relay Events:</b>	Ribbons	1st - 8th Place

**COACHES:** Meet packets can be picked up in the main office. All outstanding entry fees must be paid at the time the meet packets are picked up. There will be a brief coaches meeting on deck before the start of each session each day. Meeting location will be announced during warm-ups.

Please notify meet officials of any adaptive swimmers and their special needs upon arrival at meet.

**FINAL RESULTS:** Designated team disks may be used for initial results. Final results and/or the final Meet Backup will be e-mailed to each participating team and will be posted on the Wisconsin Swimming web page at [www.wisconsinswimming.org](http://www.wisconsinswimming.org) within one week after the meet ends. Paper copies of final results can be ordered at the Admissions table for \$10.00 each.

**CONCESSIONS:** Available in the cafeteria throughout the course of the meet. **Please no food within the competition area.**

**LOST & FOUND:** Located at the awards table throughout the meet. Lost and found items will be available for 2 weeks following the meet by contacting GSSC at [gsscinfo@wi.rr.com](mailto:gsscinfo@wi.rr.com).

**FIRST AID:** Any person requiring any first aid should report to a Lifeguard and must notify the Meet Director.

**CONDUCT:** Each team is responsible for the conduct of their own swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition and any damages may be assessed to the responsible parties. Please sit in the designated areas for teams and spectators. All spectator seating is in the upper bleachers. All swimmers must keep their swim bags in the TEAM seating areas, not the spectator seating areas. In accordance with USA Swimming rules, **NO SPECTATORS ARE ALLOWED ON THE POOL DECK**. By order of the Brown Deer Fire Department, there is no standing or sitting in the aisles and stairwells of the pool or the hallway adjacent to the pool.

**NOTE:** All Wisconsin USS rules are in effect. **No smoking allowed.**
