- WARMUP: Warm-up: 8-9 AM as follows: 8-8:30 circle swim all lanes NO diving. 8:30-8:55 one way sprints with dive lanes 3&4, push 50's 1&6, circle lanes 2&5. Failure to follow warm-up guidelines may result in disqualification from the next individual event. Meet starts at 9:05 AM.
- **POOL:** Six lane, 25 yard pool, 8.5' starting depth, 30" blocks with non-turbulent lane markers and backstroke flags.
- **TIMING:** Colorado System with back-up watches and across the board judging in case of a malfunction. All events are timed finals. Computerized scoreboard for all lanes.
- **OFFICIAL RULES:** Current Official Short Course USA and Wisconsin Rules shall prevail for this meet. Swimmers must be registered USA Swimming members. Age as of May 6, 2006. Please note any special requirements for adaptive swimmers on the entry form.

- **ENTRY LIMIT**: Swimmers may compete in Four (4) individual events plus relays.
- **FEES:** Individual events \$3.00 per event and \$8.00 per relay. \$2.00 LSC surcharge per swimmer swimming in at least one individual event. Please make checks payable to **LAKE COUNTRY SWIM TEAM**. Entry fees must accompany the official entry forms and are not refundable.
- **DECK ENTRIES:** Deck entries will be at the discretion of the meet director depending on the availability of open lanes. No new heats will be created once seeded.

ENTRY DEADLINES: Completed entry form, waiver and fees must be received no later than Thursday April 27, 2006 by the entry chair. No phone entries will be taken. This meet is being run with Hy-Tek swim software. Teams wishing to submit their entries via e-mail or disk are encouraged to do so. No disks will be given to teams who do not enter their team by disk, or provide a disk at the meet. No seed times will be changed once the entry chair has seeded the meet.

- ADMISSIONS: Admission for spectators over 13 years old is \$3.00. Heat sheets are \$2.00.
- **PARKING:** Parking is available in the west lot. Access is readily available to eliminate a long walk. Note: You must park in a designated marked parking space or you will receive a ticket.

FINAL RESULTS: One copy of meet results will be sent to each team represented. All others wishing results can order them at the admissions table for \$10.00 per copy. Teams will be responsible for picking up their disk at the conclusion of the meet. No disks will be mailed with final results.

CONDUCT: Each team is responsible for the conduct of its swimmers.


