- WARMUP:** AM session: 7:30-8:30 AM as follows: 7:30-8:00 circle swim all lanes NO diving.  
8:00-8:30 one way sprints and push 50's as needed. Meet starts at 8:35 AM. PM Session: Warm-ups 45 minutes. Meet starts 50 minutes after conclusion of AM session.
- POOL:** Six lane, 25 yard pool, 5'1" starting depth, 30" blocks, non-turbulent lane markers and backstroke flags.
- TIMING:** Colorado System with back-up watches and across the board judging in case of a malfunction. All events are timed finals.
- OFFICIAL RULES:** Official current USA Swimming Rules shall prevail for this meet. Swimmers must be registered USS swimmers. Age as of May 5th, 2007. Please notify meet officials of any disabled swimmers upon arriving at the meet.

- ENTRY DEADLINES:** Completed entry file, waiver and fees must be received no later than Thursday April 26<sup>th</sup>, 2007 by the entry chair. No phone entries will be taken. This meet is being run with Hy-Tek swim software. Any teams wishing to submit their entries via disk or e-mail are encouraged to do so. No seed times will be changed once completed form or disk has been received by entry chair. Please note any special requirements for adaptive swimmers on the entry form.
- ENTRY LIMIT:** Swimmers may compete in four (4) individual events plus relays.
- FEES:** Individual events \$3.00 per event and \$10.00 per relay. \$2.00 LSC surcharge per swimmer entered in at least one individual event. Deck entries shall be \$6.00/individual event and \$16.00/relay entry. Please make checks payable to LAKE COUNTRY SWIM TEAM. Entry fees must accompany the official entry forms and are not refundable.
- ADMISSIONS:** Spectators 13 years old and over are \$3.00. Heat sheets are \$2.00 per session.
- PARKING:** Parking is available in the north lot.
- FINAL RESULTS:** One copy of meet results will be sent to each team represented. All others wishing results can order them at the admissions table for \$10.00 per copy. All coaches needing a disk of final results may pick them up in the computer room following the meet. Results will be emailed to teams providing an email address.
- CONDUCT:** Each team is responsible for the conduct of its swimmers.

High Point Awards: 1<sup>st</sup> through 12<sup>th</sup> in each age group including Senior.  
High Point awards will be presented to the individual winners at the conclusion of each session.  
All individual and relay ribbons will be available during the meet. No awards will be mailed.
- SCORING:** USA Swimming/HY-Tek Single-Age Power Performance points will be used for scoring in 9,10,11,12,13 and Open age groups. Traditional 12-place scoring will be used for 6-under, 7 and 8 year-old age groups.
- FOOD:** A superb selection of hot and cold food and beverages will be available in the cafeteria.
