TIMELINE:	Saturday AM Session:Warm-ups 8:00 a.m.Meet Starts: 9:05 a.m.Saturday PM Session:Warm-ups begin at the end of the AM session,but not before 1:05 p.m. The PM session warm ups will last one hour.
TIMING:	Events will be timed and judged by Colorado automatic timing system and judging equipment. Colorado horn starting system. Two back-up timers per lane will be provided.
ENTRIES:	EACH SWIMMER WILL BE LIMITED TO FOUR (4) INDIVIDUAL EVENTS, PLUS RELAYS. Swimmer's age as of May 12, 2007 will determine his/her age group. Deck entries will be accepted if open lanes are available and number of entries permit. Parents should come to the pool office to complete the forms.
ENTRY DEADLINE:	Completed individual and relay entry forms, waiver and fees must be received no later than <u>April 27, 2007</u> . All entries should be submitted either on the enclosed entry form or on a Hy-tek Team Manager diskette. Submit all seed times in yard cutoff times. Be sure to indicate any UNATTACHED swimmers. Hytek entries will be accepted and are preferred. Please include a hard copy with all disk entries.
ENTRY FEES:	\$3.00 per individual event, \$10.00 per relay team and \$2.00 splash fee per swimmer. Entry fees must accompany entry forms. Recap statement must be complete and the waiver form signed. Money used for reservations is nonrefundable and cannot be used to offset cost of relays, deck seeding or splash fees. The entry fee for deck entries will be \$5.00 for individual and \$10.00 for relay. Checks should be made payable to MENOMONEE FALLS SWIM CLUB.
WARM-UPS:	<b>FEET FIRST ENTRY ONLY FROM THE STARTING END OF THE POOL.</b> AM Session: Lane 6 will be reserved for 8&U swimmers only, 35 minutes of circle swimming with no racing starts, then 25 minutes for one way sprints with starts. Both Sessions: 35 minutes of circle swimming with no racing starts. The next 25 minutes: Lanes 3 & 4 - one way sprints with starts; Lanes 1, 2, & 5 (lane 6 in p.m. session) - continue as circle swim only. Additional lanes for one way sprints with starts may be opened at the discretion of the Meet Director. Violators of the Wisconsin Swimming warm-up procedures may be subject to disqualification.

- SEEDING: All age groups will be pre-seeded.
- **ELIGIBILITY:** All swimmers must be currently registered with United States Swimming and the USA numbers must appear on the entry form/disk. Out of state entrants must being their USA swimming cards and be prepared to show them to Clerk of Course. To deck register, the swimmer shall pay the annual United States Swimming registration fee of \$47.00 plus a \$15.00 surcharge.
- AWARDS: All swimmers achieving A-BB times that were entered at B-C times, will receive an achiever award. A-BB and B-C swimmers will compete together and be awarded separately. Swimmers are placed in the A-BB or B-C division based upon their entry times.

Individual Event Awards – 1<sup>st</sup> to 3<sup>rd</sup> place medals, 4<sup>th</sup> to 12<sup>th</sup> place ribbons, Relay Events Ribbons: 1<sup>st</sup>-6<sup>th</sup> Heat winner awards will be given for all events for 10 and under age groups. All medals and ribbons will be available for pick-up during the meet. No awards will be mailed.

- ADMISSION: \$3.00 plus \$3.00 for heat sheet.
- COACHESCoaches may pick up their packets in the pool office. Any monies owed must be<br/>paid before you can obtain your packet. Please be prepared to show your USA<br/>Swimming Coach Card at the time you pick up your team packet. Coach's cards<br/>must be visible at all times on deck.
- **OFFICIAL RULES:** 2007 USS Wisconsin Swimming Rules shall govern this meet. 500 swimmers will need to provide their own counters.
