- TIMELINE:** Saturday AM Session: Warm-ups 7:30 a.m. Meet Starts: 8:30 a.m.
Saturday PM Session: Warm-ups begin at the end of the AM session, not before 12:30 p.m. The meet will begin one hour after warm-ups begin.
Sunday: Warm-ups 7:30 a.m. Meet Starts: 8:30 a.m.
Sunday PM Session: Warm-ups begin at the end of the AM session, not before 12:30 p.m. The meet will begin one hour after warm-ups begin.
- SPECIAL NOTE:** The Village of Menomonee Falls hosts the Vince Lombardi Charity Annual Run and Walk the morning of June 9th. We will be getting special directions from the Menomonee Falls Police Department for Saturday morning meet participants and spectators to get to and from the High School. These will be provided to all teams with reservations well in advance of the meet. It is each team's responsibility to communicate this to all concerned. We expect this to have limited impact as the run/walk begins at 9:00 a.m. and should be over by noon.
- TIMING:** Events will be timed and judged by Colorado automatic timing system and judging equipment. Colorado horn starting system. Two back-up timers per lane will be provided.
- ENTRIES:** **EACH SWIMMER WILL BE LIMITED TO FOUR (4) INDIVIDUAL EVENTS, PLUS ONE (1) DISTANCE EVENT, PLUS RELAYS PER DAY.** Swimmer's age as of June 9, 2007 will determine his/her age group. **Deck entries will be accepted if open lanes are available and number of entries permit.** Parents should come to the pool office to complete the forms. Distance events will be positive check in, which will close the end of session warm-ups.
- ENTRY DEADLINE:** Completed individual and relay entry forms, waiver and fees must be received no later than **Friday, May 25, 2007**. All entries should be submitted either on the enclosed entry form or on a Hy-tek Team Manager diskette. Submit all seed times in yard cutoff times. Be sure to indicate any UNATTACHED swimmers. **Hytek entries will be accepted and are preferred.** Please include a hard copy with all disk entries.

ENTRY FEES: \$3.00 per individual event, \$10.00 per relay team and \$2.00 splash fee per swimmer. Entry fees must accompany entry forms. Recap statement must be complete and the waiver form signed. Money used for reservations is nonrefundable and cannot be used to offset cost of relays, deck seeding or splash fees. The entry fee for deck entries will be \$5.00 for individual and \$12.00 for relay. Checks should be made payable to MENOMONEE FALLS SWIM CLUB.

WARM-UPS: **FEET FIRST ENTRY ONLY FROM THE STARTING END OF THE POOL.**
The warm-up sessions will be 55 minutes long. Warm up procedures as follows:
AM Session: First 30 minutes Last 15 minutes
Lanes 1-3 Circle swim Sprints
Lanes 4-5 Circle swim Circle swim
Lane 6 Circle swim Pace
PM Session: First 30 minutes Last 25 minutes
Lane 1 Circle swim Pace
Lanes 2-3 Circle swim Sprints
Lanes 4&5 Circle swim Circle swim
Lanes 6 (8&U only) Circle swim Starts/sprints
Violators of the Wisconsin Swimming warm-up procedures may be subject to disqualification.

SEEDING: All age groups will be pre-seeded with the exception of distance events.

ELIGIBILITY: All swimmers must be currently registered with United States Swimming and the USA numbers must appear on the entry form/disk. Out of state entrants must bring their USA swimming cards and be prepared to show them to Clerk of Course. To deck register, the swimmer shall pay the annual United States Swimming registration fee of \$47.00 plus a \$15.00 surcharge.

AWARDS: Individual Event Medals – 1st to 3rd
Relay Events Ribbons: 4th to 12th
Heat winner awards will be given for all events for 10 and under age groups. All awards will be available for pick up during the meet. No awards will be mailed.

ADMISSION: \$3.00 plus \$3.00 for heat sheet

COACHES PACKETS: Coaches may pick up their packets in the pool office. Any monies owed must be paid before you can obtain your packet. Please be prepared to show your USA Swimming coaches card at the time you pick up your team packet. Coach's cards must be visible at all times on deck.

OFFICIAL RULES: 2007 USS Wisconsin Swimming Rules shall govern this meet. 500 and 1000 swimmers will need to provide their own counters.

DISABLED SWIMMERS: Please notify meet officials of any disabled swimmers upon arriving at meet.

FOOD: A concession stand will offer a wide selection of food and beverage available outside the pool area. **No** food or coolers will be allowed in pool area.

CONDUCT: All teams will be responsible for the conduct of their own swimmers. The Meet Marshall and Meet Director shall have authority to disqualify swimmers for misconduct.

FIRST AID: A First Aid kit will be available in the pool office.

- LOST&FOUND:** Located in the pool office. After the meet, please contact the meet director. Lost & found will only be held for two weeks after the meet. Any remaining items will then be donated to charity.
- FINAL RESULTS:** One copy of meet results will be e-mailed to each participating team. Results will also be posted on the Wisconsin Swimming website.
- REST AREA:** The rest area will be restricted to the pool and the hallways adjacent to the pool. Swimmers will not be allowed in other areas of the school.
- SMOKING:** Per USA Swimming rules, smoking is NOT permitted in areas designated for swimmers, including the rest areas and pool. Menomonee Falls High School is a SMOKE and DRUG FREE ZONE.
- 100 YD RELAYS:** The second and fourth leg of 100 yard relays must start in the water from push starts due to pool depth issues.
