- FACILITY:** 25 yard pool with 6 lanes, non-turbulence lane markers and backstroke flags. Pool depth on non-starting block end is 3'6" to 5'. Second and fourth leg of 100 yard relays will be started in the water. 30" slanted starting blocks into 5' pool depth and Colorado automatic timing system.

- TIMELINE:** Saturday: Warm-ups 9:05 a.m. Meet Starts: 10:10 a.m.

- PM Warm ups will begin at the conclusion of the AM session. A timeline will be provided to all participating teams so PM swimmers know approximately the starting time for PM session warm ups. It will also be posted on our website at mfswim.org.
- TIMING:** Events will be timed and judged by Colorado automatic timing system and judging equipment. Colorado horn starting system. Two back-up timers per lane will be provided.
- ENTRIES:** **EACH SWIMMER WILL BE LIMITED TO FOUR (4) INDIVIDUAL EVENTS PLUS RELAYS PER DAY.** Swimmer's age as of January 26, 2008 will determine his/her age group. **Deck entries will be accepted if open lanes are available and number of entries permit.** Parents should come to the pool office to complete the forms.
- ENTRY DEADLINE:** Completed individual and relay entry forms, waiver and fees must be received no later than **Friday, January 11, 2008**. All entries should be submitted either on the enclosed entry form or on a Hy-tek Team Manager diskette. Submit all seed times in yard cutoff times. Be sure to indicate any UNATTACHED swimmers. **Hytek entries will be accepted and are preferred.** Please include a hard copy with all disk entries.
- ENTRY FEES:** \$3.00 per individual event, \$12.00 per relay team and \$2.00 splash fee per swimmer. Entry fees must accompany entry forms. Recap statement must be complete and the waiver form signed. Money used for reservations is nonrefundable and cannot be used to offset cost of relays, deck seeding or splash fees. The entry fee for deck entries will be \$5.00 for individual and \$10.00 for relay. Checks should be made payable to MENOMONEE FALLS SWIM CLUB.
- WARM-UPS:** **SLIP AND SLIDE ENTRY ONLY FROM THE STARTING END OF THE POOL.**
40 minutes of circle swimming with no racing starts. The next 20 minutes:
Lanes 3 & 4 - one way sprints with starts; Lanes 1, 2, & 5, 6 - continue as circle swim only. Additional lanes for one way sprints with starts may be opened at the

discretion of the Meet Director. Violators of the Wisconsin Swimming warm-up procedures may be subject to disqualification.

- SEEDING:** All age groups will be pre-seeded.
- ELIGIBILITY:** All swimmers must be currently registered with United States Swimming and the USA numbers must appear on the entry form/disk. Out of state entrants must bring their USA swimming cards and be prepared to show them to Clerk of Course.
- AWARDS:** Individual Event Ribbons – 1st-12th Relay Events Ribbons: 1st-6th
Heat winner awards will be given for all events for 10 and under age groups.
High Point Trophies 1st-3rd place for 8 & under, 9-10, and 11-12 year olds for individual events. High Point Awards will be presented at the end of competition Sunday, January 27, 2008. All ribbons and trophies will be available for pick-up during the meet. No awards will be mailed.
- ADMISSION:** \$3.00 plus \$3.00 for heat sheet
- COACHES PACKETS:** Coaches may pick up their packets in the pool office. Any monies owed must be paid before you can obtain your packet. Please be prepared to show your USA Swimming Coach Card at the time you pick up your team packet. Coach's cards must be visible at all times on deck.
- OFFICIAL RULES:** 2008 USA-S Wisconsin Swimming Rules shall govern this meet. 500 and 1000 swimmers will need to provide their own counters.
- OFFICIALS:** Ted Hanson, Head Official, others TBD
- DISABLED SWIMMERS:** Please notify meet officials of any disabled swimmers upon arriving at meet.
- FOOD:** A concession stand will offer a wide selection of food and beverage available outside the pool area. **No** food or coolers will be allowed in pool area.
- CONDUCT:** All teams will be responsible for the conduct of their own swimmers. The Meet Marshall and Meet Director shall have authority to disqualify swimmers for misconduct.
- FIRST AID:** A First Aid kit will be available in the pool office.
- LOST&FOUND:** Located in the pool office. After the meet, please contact the meet director. Lost & found will only be held for two weeks after the meet. Any remaining items will then be donated to charity.
- FINAL RESULTS:** One copy of meet results will be e-mailed to each participating team and posted on the Wisconsin Swimming website.
- REST AREA:** The rest area will be restricted to the pool and the hallways adjacent to the pool. Swimmers will not be allowed in other areas of the school.
- SMOKING:** Per USA Swimming rules, smoking is NOT permitted in areas designated for swimmers, including the rest areas and pool.
- Menomonee Falls High School is a SMOKE and DRUG FREE ZONE.
