ENTRIES: EACH SWIMMER WILL BE LIMITED TO FOUR (4) INDIVIDUAL EVENTS,

PLUS RELAYS. Swimmer's age as of May 10, 2008 will determine his/her age group. Deck entries will be accepted if open lanes are available and

number of entries permit. Parents should come to the pool office to

ENTRY DEADLINE:

Completed individual and relay entry forms, waiver and fees must be received

Heat winner awards will be given for all events for 10 and under age groups. High Point Awards 1<sup>st</sup>-3<sup>rd</sup> by age groups 8&U, 9-10, 11-12 for individual event scores. High Point awards will be presented to the individual winners at the conclusion of the meet. All ribbons and trophies will be available for pick-up

during the meet. No awards will be mailed.
