- Facility:** An 8 Lane 25 yard pool with starting depth of 7 feet and a turn depth of 3 and half feet. Non-turbulent lane markers, backstroke flags. Regulation height starting blocks (30") and ample viewing area for swimmers and spectators
(seats 400)
- Timing System:** Colorado System 5. Full Matrix LED displays with AquaGrip Touchpads and Infinity Start System and 1 button plus 2 watches as back up. All events are time finals.
- Warm-ups:** The morning session will begin at 7:30am with competition beginning at 8:35am. Warm-ups for the afternoon session will begin immediately following the morning session, but **WILL NOT START BEFORE 11:00AM**. Afternoon competition will begin 50 minutes after the start of the afternoon warm-ups.
First 30 minutes – circle swim all lanes
Next 30 minutes – Lanes 3,4,5 Dive/Sprints
Lanes 1, 8 for 8 & Under only
Lanes 2, 6, 7 circle swim
Failure to follow warm-up guidelines may result in disqualification from the next individual event
- Rules:** Official 2003 Short Course USA Swimming Rules shall prevail for this meet. Swimmers must be registered WISCONSIN USA Swimming swimmers. Swimmers' age is as of December 7, 2003. Relays: first and last names of competing swimmers and order of swimming must be listed on the back of the card along with age, prior to swimming the relay.
- Entries:** Completed entry forms, signed waiver, and fees must be received by **Wednesday, November 26**. Preferred method of entry is by diskette in **Hy-Tek CommLink** format. Diskettes **MUST** be accompanied by a hard-copy listing. Current USAS ID number **MUST** be included on the entry form. All deck entries must be able to prove USAS membership. **Out of state swimmers are welcomed and must show their current USAS card prior to swimming.**

- Entry Limit:** Only the first 1600 individual entries will be accepted. Entries not accepted will be notified by phone as soon as possible. Swimmers are limited to four(4) individual events plus two(2) relays.
- Entry Fee:** Individual events: \$3.00
Relays: \$10.00
Splash fee: \$1.25

- Awards:** Awards for relay events will consist of ribbons for **1st-6th places**. Awards for individual events will consist of medals for **1st-3rd places** and ribbons for 4th-16th place. Heat winners for 8 & Under and 10 & Under events will receive ribbons. Swimmers must claim their own awards. Awards will not be mailed.
- Adaptive Swimmers:** Any coach of a swimmers(s) with special needs must notify the head official of those needs at the beginning of the warm-ups.
- Seeding:** The meet will be pre-seeded. It is the swimmer's responsibility to be at the starting blocks at the start of his/her race. Staging assistant will be provided for 8 & under events.
- Final Results:** One copy of the meet result will be sent to all participating clubs. Additional copies may be ordered at \$5.00 per copy.
- Deck seeding:** Deck seeding will be allowed only to the limit of filling partially filled heats. A \$5.00 charge per event will be assessed for deck seeding. Deck seeding will close at 30 minutes before the start of each session. Swimmers unable to prove USAS membership will be charged a deck-registration fee of \$47.00.
- Admission:** Admission is free. Heat sheet will be available at \$3.00 each. Coaches' packets will be available at the admission table. Coaches and Club Officials desiring to be on deck will be required to display proof of current USAS membership at all times.
- Concessions:** Delicious hot and cold food and drink will be available at reasonable prices in the Monona Grove Cafeteria.
- Meet Conduct:** Each team is responsible for the conduct of its swimmers. The meet director, at his discretion, shall remove from competition any swimmer who behaves in a disruptive or disorderly manner.
