- WARM-UPS:** **First half hour:** Circle swim in all lanes.
2nd half hour: Sprint in lanes 3, 4 and 5
Circle swim in lane 1, 2, and 6.
- POOL:** The Pool length is 25 yards, Number of Lanes 8, Block height 26" Depth at the starting blocks 6'8" Depth at the shallow end 3'6" non-turbulent lane markers and backstroke flags. Staging for 8 & under only.
- TIMING:** Electronic timing system with backup watches and across the board judging in case of malfunction. All events are timed finals.
- OFFICIAL RULES:** Official current USA and Wisconsin Swimming Rules shall prevail for this meet. Swimmers must be registered USS swimmers. Please notify meet officials of any adaptive swimmers upon arriving at the meet.

- ENTRY DEADLINES:** Completed entry file, waiver and fees must be received no later than **Wednesday, May 30, 2007** by the entry chair. No Phone entries will be taken and please do not send seed cards. This meet is being run with Hy-Tek swim software. Any team wishing to submit their entries via disk or e-mails along with a hard copy are encouraged to do so. No seed times will be changes once complete form or disk has been received by entry chair. Please note any special requirements for adaptive swimmers on the entry form.
- ENTRY LIMITATIONS:** Swimmers are limited to four (4) individual events and two (2) relays. Age as of June 9, 2007 will determine the swimmers age group. All swimmers must have current USA Swimming registration. Meet entries are limited to 1200.

- ELIGIBILITY:** This is a sanctioned meet. Swimmers must be registered USA swimming members. Age as of June 9th, 2007.

- AWARDS:** Overall team trophy

Individual events: Medals – 1st to 3rd, Ribbons 4th to 16th.
Relay events: Ribbons – 1st to 8th.

- FINAL RESULTS:** One copy of meet results will be sent to each team represented. All others wishing results can order them at the admissions table for \$5.00 per copy. All coaches needing a disk of final results may pick them up at the computer following the meet. Results will be e-mailed to teams providing an e-mail address.
- DECK ENTRIES:** Teams must be pre-registered. Deck seeding will be allowed if there is room available in existing heats and will stop 45 minutes before the start of the meet. Meet Manager reserves the right to charge a \$5.00 deck seed charge per entry. Deck seed charge must be paid at the time the entry is made.
- EVENT STAGING:** This is a pre-seeded meet. To reduce confusion, 6&U and 8&U should report to the Clerk of Course in the seeding area prior to their events. All other swimmers report to the starting blocks prior to their events. Anyone failing to report to the Clerk of Course or the blocks in a timely fashion will be automatically scratched.
- ADMISSIONS:** Spectators over 13 years old are \$3.00 and Heat Sheets \$3.00
- CONDUCT:** Each team is responsible for the conduct of its swimmers. If in the opinion of the Meet Director or Marshall, a swimmer's or a spectator's conduct is harmful or disruptive, he/she will be asked to leave.

- FOOD:** A splendid selection of hot and cold food and beverages will be available in the cafeteria.
