ENTRIES & ELIGIBILITY

- * Individuals may enter 2 individual events on Friday. Individuals should be entered in all 5 pentathlon events per day on Saturday and Sunday even if their intention is to scratch events. Swimmers may enter in just either Saturday or Sundays pentathlon, but this will eliminate them from decathlon results.
- * All swimmers must be registered USS. Ages are as of the first day of the meet.
- * Teams having swimmers with special needs should notify the meet officials if necessary.

ENTRY DEADLINE:

- * Entries are due on **Wednesday, January 7th, 2004 at NOON**
- * No phone entries will be accepted. Fax's are only accepted in emergency cases only.
- * All entries must be accompanied by a check covering all team entries.
- * Entries and waiver **MUST** be prepared on the enclosed entry form. Print clearly OR
- * Entries generated from HyTek Team Manager must be accompanied by a hardcopy.
- * Results on HyTek disks are only available to teams that prepared the entry with a disk!

ENTRY FEE: \$3.00 per Individual entry on Friday Night and 500 Free on Sunday. Decathlon cost is \$10.00 per day, per swimmer on Sat. & Sun. regardless of how many events entered in, individual event cost ends up @ \$2.00 per event. (deck entries are double & subject to lane availability). \$1.25 per swimmer LSC Splash Fee.

ADMISSIONS: \$3.00 per spectator, per day, \$3.00 per heat sheet, per session
12-under spectators are free.
Final results are published for each participating team. Individual results are \$10.00.
