ENTRIES & ELIGIBILITY

- Teams may enter unlimited number of relays in any event with no qualifications
- Individuals may enter four (4) individual events.
- All swimmers must be registered with USA-Swimming.
- Ages are as of the first day of the meet.
- Team having swimmers with special needs should notify the meet officials if necessary.
- Timed Finals with the exception of the 1000 Free and 500 Free events which will be positive check-in (these events will also be limited to the Top 24 for each event to keep within the 4-hour timeline).

- Entries are due on TUESDAY – MAY 29TH, 2007 (EMAIL)
- Waiver/Fees Due by FRIDAY, JUNE 1ST, 2007 (MAIL)
- All entries must be accompanied by a check covering all team entries by June 3, 2007

- Entries generated from Hy-Tek Team Manager must be accompanied by a hardcopy
