- * All swimmers must be registered with USA-Swimming **NO DECK REGISTRATION WILL BE AVAILABLE THE DAY OF THE MEET.**
- * Ages are as of the first day of the meet (November 3rd, 2007)

WARM-UPS: Saturday/Sunday AM Session

General Warm-ups begin at **7:30AM-8:30AM** – as follows: 7:30-8:00AM circle swim all lanes.
FEE FIRST ENTRY ONLY – NO DIVING ALLOWED with the exception of sprints.

8:00-8:30AM one-way sprints with diving in lanes 3-4-5.

The AM Session will begin at 8:35 AM

Lane 8 during the Sunday morning session will be designated for 8/Under Swimmers ONLY.

Sunday's PM session will begin promptly after the completion of the morning session. A
