FACILITY: One eight lane (North End of Pool), 25 yard pools with non-turbulent lane markers and backstroke flags.
Pool depth at starting end is a minimum of 7'. Block height is 29.5".

BULKHEAD: The bulkhead may only be used by officials and counters during the meet. Swimmers and coaches will not be allowed to cross the pool via the bulkheads during the meet.

TIMING: Colorado System with two back-up buttons and one watch. Computerized scoreboard for all lanes.

FORMAT: The meet is governed by 2008 USA-Swimming & Wisconsin Swimming, Inc. rules
All events are timed finals and pre-seeded (with the exception of Saturday's 500 & 1000 Freestyle which will be a positive check-in event and run fastest to slowest – alternating girls and boys).
All Swimmers 8-Years and younger may report to the designated staging area. All other swimmers report to the blocks prior to your event
Heat/Events may be combined due to time constraints, but will be awarded separately.

ENTRIES & ELIGIBILITY

- * Individuals may enter a total of 3 (three) individual events on Saturday.
- * Individuals may enter a total of 4 (four) individual events on Sunday.
- * Teams may enter unlimited number of relays in any relay event with no qualifications.
- * All swimmers must be registered with USA-Swimming
- * **NO DECK REGISTRATION WILL BE AVAILABLE THE DAY OF THE MEET.**
- * Ages are as of the first day of the meet (November 8th, 2008)

WARM-UPS: SATURDAY PM SESSION
General Warm-ups begin at **1:00PM** – as follows: 1:00-1:30PM circle swim all lanes.
Sit and Slide entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition – **NO DIVING ALLOWED** with the exception of sprints.
1:30-2:00PM one-way sprints with diving in lanes 3-4-5.
SATURDAYS SESSION WILL BEGIN AT 2:05PM.

SUNDAY WARMUPS:
General Warm-ups being at **8:00AM** – as follows: 8:00-8:30AM circle swim all lanes.
Sit and Slide entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition – **NO DIVING ALLOWED** with the exception of sprints.
8:30-9:00PM one-way sprints with diving in lanes 3-4-5.
Sundays Morning Session will begin at 9:05AM
Lane 8 during the Sunday morning session will be designated for 8/Under Swimmers ONLY.
Sunday's PM session will begin promptly after the completion of the morning session. A Timeline will be emailed to all teams and posted on Wisconsin Swimming's website prior to the meet.

ENTRY DEADLINE:

- * Entries are due on **WEDNESDAY, OCTOBER 29TH, 2008**
- * No phone entries will be accepted. Fax's are only accepted in emergency cases only.
- * All entries must be accompanied by a check covering all team entries.
- * Entries and waiver **MUST** be prepared on the enclosed entry form. Print clearly.
- * **Hardcopy, Waiver and Entry Fees are due no later than Wednesday – 11/3/2008.**
- * Results on HyTek disks are only available to teams that prepared the entry with a disk!

CONDUCT: Each participating team is responsible for the conduct of their swimmers.
No coolers, sleeping bags, swim bags or large coats in pool area or common hallway.
In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.
All on deck seating will be reserved for use by the athletes and coaches. No parents are allowed on deck or in any of the on-deck seating. Any person who, in the opinion of the Meet director, Meet Referee or Meet Marshal, is harmful to others or to the property of others will be required to leave the competition venue. By order of the Brown Deer Fire Department, there will be no videotaping or picture taking allowed in any area of the stair wells or upper stair well landing areas.
