

**Oregon Community Swim Club****2008 Fall Open**

- DATE: **SUNDAY, November 9, 2008 \*\*SUNDAY this year- NOT Saturday\*\***
- LOCATION: **Middleton-Cross Plains Area Pool**

- FACILITY: Middleton-Cross Plains High School Pool is an 8-lane, 25-yard pool with non-turbulent lane markers and backstroke flags. Parking and Spectator Seating is available. The pool has starting depths of 4 ½ feet to 5 feet and a turn depth of 4 feet. It has regulation height starting block of 30 inches.
- SCHEDULE: Morning session warm-ups will be 7:30am-8:30am. The meet will start promptly at 8:35am. Afternoon session warm-ups will begin at the conclusion of the morning session, but not before 11:00am and last for one hour.  
Fly Over starts will be used during the meet, please inform your swimmers.
- WARM-UPS: First 30 minutes will be general warm-up/circle swim.  
Last 30 minutes: Lanes 1, 2, 7, & 8 will be circle swim.  
Lanes 3, 4, 5, & 6 will be on-way sprints.  
**Sit and Slide entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.**
- ENTRIES: Swimmers may compete in four (4) individual events plus 2 relays. Swimmers must be USA Swimming registered in order to enter. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries in the Hy-Tek commlink format.
- ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no later than **Friday, October 31, 2008**. No entries will be taken over the phone. However, email entries are encouraged and can be sent to Dan Rokicki at [Rokicki@charter.net](mailto:Rokicki@charter.net) Unless you have received a confirmatory email from the above address, it has not been received! Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline.
- SEEDING: This is a PRE-SEEDED meet. IT IS THE SWIMMERS RESPONSIBILITY TO BE AT THE BLOCKS AT THE START OF HIS/HER MEET. Staging will be provided for 8 & under swimmers.
- DECK SEEDING: Deck seeding will be allowed only to the limit of partially filled heats. An \$8 per individual event charge will be assessed for deck seeding. Deck seeding for relays will be \$6.00 per swimmer. Deck seeding will close at 8:00am for the morning session, and one-half hour before the beginning of the afternoon session.
- ENTRY FEES: \$3.00 LSC splash fee per swimmer, \$4.00 per individual event and \$12.00 per relay.
- FINAL RESULTS: A copy of the final results will be emailed to all participating clubs.

- TIMING SYSTEM:** All events (with the exception of 25-yard races) will be timed using a Colorado Timing System with horn start, touch pads, one button, and two watches as backup. 25-yard races will be timed with two (2) stopwatches.
- Special Needs SWIMMERS:** Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs prior to the start of the meet.
- AWARDS:** 1<sup>st</sup> through 3<sup>rd</sup> place medals for all individual events. 4<sup>th</sup> through 16<sup>th</sup> place ribbons will be awarded for individual events. Heat winners for 8&U and 10&U individual events will receive rewards on deck. 1<sup>st</sup> through 3<sup>rd</sup> place ribbons will be given for all relay events. Swimmers may collect awards during the meet, or Coaches at the end of the meet. Awards will not be mailed. Awards will be located in Small Gym—Follow the Arrows.
- OFFICIALS:** Ann Moffat-Lead Official  
2008 USA Swimming and Wisconsin Swimming LSC rules apply to this meet. All out of state swimmers must bring their USA-S card to the meet.  
Swimmers not reporting to the blocks at the start of their event will be scratched.
- MEET CONDUCT:** Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition. No parents/guardians allowed on Pool Deck.
- Only Coaches, Swimmers, and Meet Workers are allowed on the pool deck.
- In accordance with the Federal Video Voyeurism Prevention Act of 2004- the use of camera phones or video recording devices in the locker rooms is prohibited.
- Coaches' packets will be available at the data entry table. Coaches and Club Officials desiring to be on deck will be required to display proof of current USA Swimming membership at all times.
- ADMISSIONS:** Admission is \$ 1.00 for those guests 18 years and older. Programs will be available for \$5.00.
- CONCESSIONS:** Delicious hot and cold foods will be available for purchase throughout the meet.  
No Food is allowed in the pool area.
