Timing System:	A fully automatic Colorado timing system with 2 manual back-up buttons and two back-up timers for each lane will be used. If the automatic system fails, a gun or horn start will be used.
General Rules:	Official 2007 USA Swimming and WI LSC rules shall prevail at this meet. Age as of July 14, 2007.
Entry Deadline:	Team entries on Hy-Tek disk, hard copy, waiver, and fees must be received by the Entry Chair no later than 6:00pm, July 2, 2007 . If you submit entries via email, hard copy, waiver, and fees must be received no later than 6:00pm, July 2, 2007. Please do not submit more entries than you have reserved, unless you have checked with the Meet Director.
Entry Fees:	\$4.00 per individual events, \$12.00 per relay, and \$2.00 WI LSC Splash fee for each swimmer entered in the meet. Checks made payable to "SEAY" and delivered with entries. NOTE: Please be sure the waiver is signed. We cannot accept entries without a waiver.
Entry Limit:	4 events per day with unlimited relays.
Deck Entries:	Will be accepted to fill open lanes. No additional heats will be added. \$6.00 per individual event and \$12.00 per Relay. WI LSC Splash fee of \$2.00 due if swimmer is not already entered in meet.
Format:	All events will be swum combined and then separated for awards, with the exception of the 8 & Under and Senior age-groups and relay events, which will be swum and awarded as one class. The 12 & Under 500 Free event will be awarded separately using the 11-12 WI LSC State

	qualifying time as the State Time for this event. All events will be pre-seeded with the exception of the 12 & U 500 Free, Senior 500 Free, 11-12 400 IM, and Senior 400 IM. The 12 & Under 500 Free, Senior 500 Free, 11-12 400 IM, and Senior 400 IM are positive check-in events and will be deck seeded. Fly over starts may be used. Relays are mixed and can consist of any combination of male and female swimmers. 8 & U will be staged. Please note: Heats/events may be combined due to time constraints, but will be awarded as separate age groups.								
Deck Seeded Events:	The 400 IM and 500 Free events will be positive check-in events and seeded on deck. These events may be combined and/or limited by Meet Management to adhere to the four (4) hour session rule. Swimmers cut from these events will be refunded their entry fee or that fee can be used to deck seed in any open lane or event. Positive check-in for these events will be located at the Scoring & Records table. Positive check-in will close 30 minutes before the start of the session in which the event is swum. The Wisconsin Scratch rule will not be in effect for this meet.
