- LOCATION:** UWM – Klotsche Center

- FACILITY:** Pool is a 25 yard 8 lane pool with non-turbulence lane markers and backstroke flags. Block height is 30 inches at a pool depth of 14 feet.
- TIMING:** Colorado™ timing system and scoreboard, in addition to manual stopwatches with two timers.
- RULES:** 2005 USA Swimming & Wisconsin short course rules prevail for this meet. In the event of a *false start*, athletes will not be recalled; a *recall rope* will not be utilized, with the exception of an equipment malfunction.
- TIME SCHEDULE:** WARMUPS: 7:00 a.m. to 8:00 a.m. MEET begins at 8:05 a.m.
- The first 1/2 of the warm-up time will be general warm-up only. Entry into the water shall be feet first & only circle swimming allowed. The second 1/2 of the warm-up shall be for sprinting in lanes 3, 4, 5, 6 and others as needed. One directional swimming from the starting end only, racing starts from starting blocks permitted. Lanes 1, 2, 7 and 8 will remain open for general warm-up.
- MEET FORMAT:** All events are timed finals and are pre-seeded. Swimmers must report directly to the blocks for all events.
- RELAYS:** Relay cards will be provided in the coach's packet. Coaches should complete the relay cards. Names, ages and order of swimming must be **LEGIBLY PRINTED** on the back of the card before the event is swum. Completed cards must be brought to the blocks and given to the timers by the relay swimmers swimming the event when the event is called.
- AWARDS:** Individual and Relay Events: Ribbons for 1st - 16th. Team awards: each swimmer on the first place and second place teams will receive an award. Individual scoring: 20-17-16-15-14-13-12-11-9-7-6-5-4-3-2-1. Relay scoring at 2x individual scoring.
- ADMISSION FEE:** \$2.00 admission fee per spectator and \$2.00 per heat sheet.
- ELIGIBILITY:** Wisconsin swimmers must be registered with the Wisconsin Local Swim Committee (LSC). All swimmers must be registered with USA Swimming. Swimmer age as of November 12, 2005 shall determine age group eligibility.
- ADAPTIVE SWIMMERS:** If entering an adaptive swimmer, please have the coach make a note to that effect on the meet entry information.

ENTRY DEADLINE

Mailed entries must be post-marked by Thursday, November 3, 2005 and received by Saturday, November 5th, 2005. E-mail entries will be accepted no later than Saturday, November 5th, 2005 Meet Waiver Form and payment must be mailed and postmarked by Saturday, November 5th, 2005. E-mail entries should not be assumed as accepted unless a confirmation e-mail reply is received. E-mail: MeetDirector@ShorewoodSwimClub.Com

ENTRY FEES:

\$3.00 per individual event and \$8.00 per relay and a \$2.00 Splash fee per swimmer; payable to: SHOREWOOD SWIM CLUB. All fees must accompany entries and are not refundable.

ENTRIES:

Teams are initially limited to a total of 125 individual entries. Each swimmer may compete in up to three (3) individual events plus relays. The meet will be run using the HY-TEK Meet Manager™ software system. All entries must be submitted via email to MeetDirector@ShorewoodSwimClub.Com (preferred) or on 3.5" disk in Hy-Tek format (.CL2) . Disks will be available for retrieval at meet.

ENTRY TIMES:

Submit most current achieved **yard times**.

OUT OF STATE:

Entrants must bring current USA card to the meet.

DECK ENTRIES:

Any deck entries which are accepted require the submitting club to supply Name, Birth Date, and valid registration number. Teams deck entering any swimmers are responsible for any fines or fees which are levied due to incorrect data. An additional surcharge of \$5 dollars per event will be charged. Deck entries will be permitted in empty lanes only and are solely at the discretion of the Meet Director.

DECK REGISTRATION:

Will not be allowed at this meet.

FINAL RESULTS:

All teams will be e-mailed a copy of final results within 24 hours after completion of the meet unless they request in writing a hard copy of the results. Results (HTML report and cl2) will also be posted to www.ShorewoodSwimClub.Com and www.WisconsinSwimming.Org.

CONCESSIONS:

Assorted food and drink items will be available at the meet.

CONDUCT:

All clubs will be responsible for the conduct of their own swimmers. The meet marshals and meet directors have the authority to disqualify swimmers found misbehaving. Per USA, only coaches, swimmers, and Shorewood Swim Club meet workers are allowed on deck. Coaches must display USA credentials at all times while on deck. The Klotsche Center is currently under construction. All construction zones are off limit inside and outside of the center. The Klotsche center is open for University sponsored events, faculty and student use. We are guests using the pool. Other than the showers we do not have free use of the remaining facility.

LOST & FOUND:

Located near the table where Heat Sheets are sold.

FIRST AID:

First Aid will be available at the scoring table.

OFFICIALS:

There will be a minimum of two starter referees and four total officials.
