FACILITY: 25-yard pool with eight 7' lanes, non turbulent lane markers and backstroke flags,

30" blocks, 14' depth at starting blocks 4' depth for bulk head starts, custom-designed

gutters and bulkhead.

TIMING: Colorado 5TM timing system and scoreboard, in addition to manual stopwatches

with two timers.

RULES: 2006 USA Swimming & Wisconsin LSC rules prevail for this meet. In the event of a

false start, athletes will not be recalled; a recall rope will not be utilized, with the

exception of an equipment malfunction.

TIME SCHEDULE: AM Session – 14 & Under

WARM-UPS: 7:00 to 8:00 a.m. Meet begins: 8:05 a.m.

The first 1/2 of the warm-up time will be general warm-up only. Entry into the water shall be feet first & only circle swimming allowed. The second 1/2 of the warm-up shall be for one-way sprinting in lanes 3 and 6, with additional lanes as needed. Lanes 1,2,4,5,

7, & 8 will remain open for general warm-up, unless needed for 1-way sprints.

MEET FORMAT: All events are timed finals and are pre-seeded. Swimmers must report directly

to the blocks for all events.

RELAYS: Mixed Gender Pineapple relays will be offered (6x50-any combination of boy/girl).

Relay cards will be available in the coach's packet at the beginning of the meet.

AWARDS: Pentathlon awards will be given to the lowest 8 combined times in 5 events for each age

group (excluding relays). Ribbons will be awarded to the top 16 swimmers in each event. Winning relay teams will be awarded Pineapples. Athletes will not be considered for pentathlon awards if they do not swim and successfully complete 5 individual events. All

swimmers will receive commemorative T-Shirt.

ADMISSION FEE: \$2.00 admission fee per spectator and \$3.00 per heat sheet.

ELIGIBILITY: Wisconsin swimmers must be registered with the Wisconsin Local Swim Committee

(LSC). All swimmers must be registered with United States Swimming (USS). Swimmer's age as of April 30th, 2006 shall determine age group eligibility.

ENTRY FEES: \$20.00 per swimmer/session (for up to 5 individual events @ \$3/event, t-shirt, and awards

> earned) and a \$2.00 Splash fee per swimmer; relays are \$12.00 per entry, payable to: **SHOREWOOD SWIM CLUB**. All fees must accompany entries and are not refundable.

ENTRIES: Each swimmer may compete in up to five (5) individual events and one (1) relay. The

meet will be run using the HY-TEK Meet ManagerTM software system. All entries must

be submitted via e-mail or on the enclosed entry forms with a HY-TEK Meet Manager™ compatible disk (CD-ROM) with printed hard copy. Results will be available for review on the Shorewood swim club web site; file results CL2 files will be distributed to one designated e-mail address for each participating club following the

meet.

ENTRY TIMES: Submit most current achieved vard times.

OUT OF STATE: Entrants must bring current USA Swimming card to the meet.

DECK ENTRIES: We will not accept deck entries at this meet.

FINAL RESULTS: All teams will be e-mailed a copy of final results and CL2 file within 24 hours after
