- Meet Format: All events are timed final and pre-seeded. Swimmers must report
directly to the blocks for all events.
- Entries: Swimmers will be allowed up to five (5) individual events and one
(1) relay for the meet. Entries should be submitted in most current
yard times.
- Relays: Mixed gender Pineapple Relays will be offered by age
group(6x50-any combination of boy/girl). Relay sheets will be
available in the coach's packet at the beginning of the meet.
- Awards: Pentathlon awards will be given to the highest 8 combined scores
based on the HyTek Age Group Point system for each gender and
age group. Ribbons will be awarded to the top 16 swimmers in
each event. Winning relay teams will be awarded pineapples. All
swimmers will receive a commemorative meet T-Shirt.
- Admissions: \$3.00 per spectator and \$2.00 per heat sheet

- Eligibility:** All swimmers must be registered with USA Swimming prior to meet entries being submitted. Coaches/entry chairs will be notified by Wisconsin Swimming of any swimmer not registered, or registered for the meet incorrectly, and the swimmers must be properly registered prior to the start of the meet. Swimmer's age as of April 29th will determine age group eligibility. Out of state swimmers must bring current USA Swimming card to the meet.
- Disabled Swimmers:** If entering a disabled swimmer, please make a note to that effect on the meet entry.
- Entry Deadline:** Final entries will be due **Wednesday, April 18th**. All teams are encouraged to use e-mail entries in Hy-Tek .cl2 format.

- Deck Entries:** Deck entries at \$5.00 per event will be accepted to fill open lanes, at the discretion of the meet director. Submitting club must supply full name, birth date, and a valid registration number. Teams deck entering will be responsible for any fines or fees levied due to incorrect data. Swimmers deck entering at the meet will not receive a T-Shirt.
- Deck Registration:** Deck Registration will not be allowed at this meet.
- Final Results:** Final results will be e-mailed to each participating team. Results will also be posted www.shorewoodswimclub.com and www.wisconsinswimming.org.
- Concessions:** Assorted food and beverage items will be available at the meet.
- Conduct:** All clubs will be responsible for their own swimmers. The meet marshals, meet directors, and meet referee have the authority to disqualify swimmers found misbehaving. Per USA Swimming guidelines, only swimmers, coaches, and Shorewood Swim Club meet workers will be allowed on the deck.
