- Timing: Colorado VI timing system, in addition to manual timing (two timers with watches)
- Rules: 2007 USA Swimming & Wisconsin Swimming rules shall prevail
- Time Schedule: Warm Ups: 7:00-7:30 general warm-ups  
7:30-8:00 at least two sprint lanes, more as needed  
Meet Start: 8:05

- Meet Format: All events are timed final and pre-seeded. Swimmers must report directly to the blocks for all events.
- Entries: Swimmers will be allowed up to four (4) individual events and two (2) relays for the meet.
- Relays: Relay sheets will be in the coach's packets. Coaches should complete the relay sheets, and return them to the scoring table by 7:30. Changes can be made in writing at the scoring table prior to the event.
- Awards: Individual events: Ribbons 1<sup>st</sup> – 16<sup>th</sup>  
Relay events: Ribbons 1<sup>st</sup> – 8<sup>th</sup>  
Team Awards for 1<sup>st</sup> and 2<sup>nd</sup> place team
- Admissions: \$3.00 per spectator and \$2.00 per heat sheet
- Eligibility: All swimmers must be registered with USA Swimming prior to meet entries being submitted. Coaches/entry chairs will be notified by Wisconsin Swimming of any swimmer not registered, or registered for the meet incorrectly, and the swimmers must be properly registered prior to the start of the meet.

- Deck Entries: Deck entries will be accepted to fill open lanes, and at the discretion of the meet director. Submitting club must supply full name, birth date, and a valid registration number. Teams deck entering will be responsible for any fines or fees levied due to incorrect data. An additional surcharge of \$5.00 per event will be charged
- Deck Registration: Deck Registration will not be allowed at this meet.
- Final Results: Final results will be e-mailed to each participating team. Results will also be posted [www.shorewoodswimclub.com](http://www.shorewoodswimclub.com) and [www.wisconsinswimming.org](http://www.wisconsinswimming.org).
- Concessions: Assorted food and beverage items will be available at the meet.
- Conduct: All clubs will be responsible for their own swimmers. The meet marshals, meet directors, and meet referee have the authority to disqualify swimmers found misbehaving. Per USA Swimming guidelines, only swimmers, coaches, and Shorewood Swim Club meet workers will be allowed on the deck.

- First Aid: A lifeguard will be responsible for first aid and medical emergencies at the facility.
