# 23<sup>rd</sup> SCHROEDER YMCA "A+"

1. There will be more finals of females than males in the 12 & O age groups on Saturday night. The reasoning for this is based upon the disproportionately large number of female vs. male athletes historically competing in this meet because of the realities of high school swimming in the upper Midwest, generally more females participating in USA Swimming, as well as holding 13/14 and senior female swimmers to about a AA national standard while their male counterparts are at national A standards.

This means that there will be an additional B final for 11/12 girls and only A finals for 13/14 and senior boys. 8 & U remains timed final.

2. Friday evening and Sunday events are timed final. Sunday the 12 and Unders start at 10:05 am and the Seniors swim in the afternoon.
3. USA National individual qualifiers swim free in all of their individual events
4. Friday's events will be pre-seeded.
5. Entries will be taken on a first come, first served basis until the meet is filled.
6. Proof of time: bring proof of time to the meet, **\$50.00** fine for not making the entry standards and not proving the times. Swimmers will be barred from their next events until proof or fine paid.
7. **Please make sure that you follow the entry limits. Each swimmer is allowed seven total events! Enter in short course yard times regardless of the way your athletes achieved the time standards only!!!!**
8. Coaches pick up your team's awards, they will be bagged and will not be mailed.

**FACILITY:** The Walter Schroeder Aquatic Center is an indoor 50-meter pool with two eight-lane, 25-yard courses, with two bulkheads, 16 starting blocks (starting block height is 30 inches), 6-1/2' - 17' depth and 7' wide lanes. Colorado Timing equipment, 9 panel numeric and 2 panel numeric scoreboards will be used. Touch pads, two manual back-up buttons and watches will be used in each lane.

The following events will be TIMED FINALS:

All Friday and Sunday events; all relays, 500 and 1650 free.  
On Saturday, Top 8 relays and Top 8 in the Sr. 500 free swum with finals.

All events will be pre-seeded, except the SR 500 & 1650 Freestyles and Saturday's relays. The Admin. Referee and the Meet Director may choose to combine heats, fill empty lanes or move heats to improve the conduct of the meet. Swimmers must do a positive check in with the Clerk of Course to swim these events by the following guidelines:

Relays by the end of Sat's prelim warm up session  
Saturday's Senior 500 Free – 9:00 AM  
Sunday's 1650 Free – 2:00 PM

**AWARDS:** **Custom Medals:** 1-8 for individual events; 1-3 for Relays; **Ribbons:** 4-8 Relays; **Team Trophies:** Top 3 teams (host team ineligible). A **High Point Award:** Each Age Group and Senior. All awards will be bagged by each team and a team representative may pick them all up at the end of the meet on Sunday. Awards will not be mailed.

**SCORING:** Individual Events: 9-7-6-5-4-3-2-1 Relays: 18-14-12-10-8-6-4-2

**ELIGIBILITY:** All swimmers must be registered with USA Swimming and their USA

Swimming numbers included on the entry. Age is as of Friday, February 7, 2003.

**2003 A+  
ENTRIES:**

Total entries for the meet will be limited to 2700 swims per day.

**LIMIT:** Enter no more than seven individual events for the meet. **On Saturday, athletes may enter a maximum of three individual events as it is a prelim/final session.** If athletes are entered in more than the limit, the overage event(s) for the day or meet will be dropped.

**FEES:** \$ 4.75 per individual event  
\$12.00 per relay  
\$1.25 Wisconsin LSC Splash fee per individual swimmer.

Schroeder YMCA athletes and USA National qualifiers do not pay entry fees. This meet will be using HY-TEK's Meet Manager for Windows. If you are using Team Manager, e-mail your entry. PLEASE ALSO SEND A PRINTED COPY OF YOUR ENTRIES.

**MEET FINES:**

Swimmers who are disqualified or who fail to swim qualifying times in events must either prove the qualifying time or pay a **\$50.00 fine** before their next event. Swimmers who fail to make the cut-off time, but still make Finals, may swim Finals only if they can prove the time. Official meet results are acceptable proofs of time. The host team reserves the right to make exceptions for its swimmers.

Teams are encouraged to return their entries well before the deadline. No changes, updates, additions will be made after the deadline. We will make changes as late as possible for typos, blunders, errors. Because of an LSC rule, entries from teams from outside Wisconsin may not be accepted until December 20, although out of state teams returning their entries before December 20, will be prioritized by their entry's arrival date.
