- WARMUP:** Warm-up: 8:00-9:00 AM as follows: 8-8:30 circle swim all lanes NO diving. 8:30-9:00 one way sprints with dive lanes 3&4, push 50's 1&6, circle lanes 2&5. Failure to follow warm-up guidelines may result in disqualification from the next individual event. Meet starts at 9:05 AM.
- FACILITY:** Eight lane, 25 yard pool, 13 foot starting depth, 30" blocks with non-turbulent lane markers and backstroke flags. The pool features a 12 ½ by 14 ½ foot full color, digital display scoreboard. Concessions will be available. No food or beverage is allowed in the pool area.
- TIMING:** Colorado System 6 timing system with aqua grip touch pads.
- OFFICIAL RULES:** Current Official 2005 Short Course USA and Wisconsin Rules shall prevail for this meet. Swimmers must be registered USA Swimming members. Age as of October 8, 2005. Out of state entrants must bring current USA Swimming cards. Coaches must display their current Coaches Card while on deck. Coaches should notify meet officials of any adaptive swimmers upon arrival at the meet.
- OFFICIALS:** TO BE ANNOUNCED
- ENTRY LIMIT:** **Swimmers may compete in Four (4) individual events.**
- LIMITED EVENTS:** The 400 IM and 500 Free may be limited to the top 24 entered times. The 1650 may be limited to the top 16 entered times.
- FEES:** Individual events \$4.00 per event. \$2.00 LSC surcharge per swimmer swimming in at least one individual event. Deck Entries will be \$6.00 and will be at the discretion of the meet director depending on the availability of open lanes. No new heats will be created once seeded.  
**A processing fee of \$2.00 per swimmer, up to a team maximum of \$50, will be charged for swimmers or teams not entering their entries via Hy-tek file. Entry Fees must accompany the official entry forms and are not refundable.**
- ENTRY DEADLINE:** Completed entry form, waiver and fees must be received no later than noon on Friday, September 30<sup>th</sup>, 2005. No phone entries will be taken. This meet is being run with HY-Tek swim software. Teams wishing to submit their entries via disk or mail are encouraged to do so. No commlinked disks will be given to teams who do not enter their team by disk. No seed times will be changed once the entry chair has seeded the meet.
- ADMISSIONS:** Admission for spectators over 13 years old is \$3.00 and included the heat sheet.
- CONDUCT:** Each team is responsible for the conduct of its swimmers.
- AWARDS:** None
- FOOD:** A selection of hot and cold food and beverages will be available in the cafeteria.
