- WARMUP:** Warm-up: 8:00-9:00 AM as follows: 8-8:30 circle swim all lanes NO diving. 8:30-9:00 one way sprints with dive lanes 3&4, push 50's 1&6, circle lanes 2&5. Failure to follow warm-up guidelines may result in disqualification from the next individual event. Meet starts at 9:10 AM. SIT AND SLIDE ENTRIES DURING GENERAL WARM-UPS WILL BE ENFORCED
- FACILITY:** Ten lane 25 yard pool, 13 foot at start and 5"10" at turn end. 30" blocks with non-turbulent lane markers and backstroke flags. The pool features a 12 ½ by 14 ½ foot full color, digital display scoreboard.
Concessions will be available. No food or beverage is allowed in the pool area.
- TIMING:** Colorado System 6 timing system with aqua grip touch pads.
- OFFICIAL RULES:** Current Official 2008 Short Course USA and Wisconsin Rules shall prevail for this meet. Swimmers must be registered USA Swimming members. Age as of April 26, 2008. Out of state entrants must bring current USA Swimming cards. Coaches must display their current Coaches Card while on deck. Coaches should notify meet officials of any disabled swimmers upon arrival at the meet.
- OFFICIALS:** TBA, Starter/Referee, Bob Wesel
- ENTRY LIMIT:** **Swimmers may compete in Four (4) individual events.**
- LIMITED EVENTS:** The 400 IM and 500 Free will be positive check-in and may be limited to the top 30 entered times. Both will be swum fastest to slowest, alternating women and men. The 1650 will be positive check in and may be limited to the top 20 entered times. Swimmers must provide their own counters for the 500 Free and counters/timers for the 1650. 1650 will be swum fastest to slowest, alternating women and men.
- FEES:** Individual events \$4.00 per event. \$2.00 LSC surcharge per swimmer swimming in at least one individual event. Deck Entries will be \$6.00 and will be at the discretion of the meet director depending on the availability of open lanes. No new heats will be created once seeded. Entry Fees must accompany the official entry forms and are not refundable.
- ENTRY DEADLINE:** Completed entry form, waiver and fees must be received no later than noon on Monday, April 14th, 2008. No phone entries will be taken. This meet is being run with HY-Tek swim software. Teams wishing to submit their entries via disk or e-mail are encouraged to do so. No seed times will be changed once the entry chair has seeded the meet.
- ADMISSIONS:** Admission for spectators over 13 years old is \$4.00. Heat Sheets included.
- CONDUCT:** Each team is responsible for the conduct of its swimmers. In compliance with the Video Prevention Act the use of any recording devices is prohibited in the locker rooms.
- AWARDS:** None
- FOOD:** A selection of hot and cold food and beverages will be available in the cafeteria.
