- Afternoon session: Warm-ups will start immediately after the morning session and run for one hour. Competition will start five minutes after warm-ups end. A time line will be available October 6th at <http://home.wi.rr.com/swimswat>, or at (262)679-SWAT on the day of the meet.
- WARM UPS:** The first 30 minutes of the warm up session will be lap swimming, **entering the pool feet first only**. The next 30 minutes lanes 3, 4, 5, and 6 will be sprint swimming only. Lanes 1, 2, 7, and 8 will be for lap swimming.
- SEEDING:** All age groups will be pre-seeded.

- TIMING:** All events will be conducted as timed finals utilizing a Colorado Timing System with two back up watches per lane.
- POOL:** Pool is a 25 yard 8 lane pool with non-turbulence lane markers and backstroke flags. Block height is 30 inches at a pool depth of 14 feet.
- ENTRIES:** Meet entries will be limited to 1600 individual entries. Each swimmer will be limited to four (4) individual events plus relays. Swimmer's age as of October 7, 2001 will determine his/her age group. **Deck entries will be accepted if open lanes are available and number of entries permit.** Deck registration will not be accepted.
- Current U.S. Swimming rules for competitive swimming and the Wisconsin General Committee Rules shall prevail. All swimmers must have a current USS card for verification at the meet. Coaches must display USS cards when on the pool deck at all times.

- OUT OF STATE:** All out of state swimmers must show a current USS card.

- AWARDS:** Medals for 1st-3rd and ribbons for 4th-12th on all individual events. All age classifications will be awarded as one. Relays will be awarded ribbons 1st-8th. Heat winner ribbons will be awarded. 1st, 2nd, and 3rd place individual High Point awards will be given for each age group and sex.
- SCORING:** Individual scoring will be 16, 13, 12, 11, 10, 9, 7, 5, 4, 3, 2, and 1 for the top twelve finishers in each event. Scoring will not transfer across age group classes.
- ADMISSION:** \$2.00 plus \$3.00 for a heat sheet. Results will be provided to all participating teams at no charge. Additional result sheets may be purchased at the admission table for \$10.00.
- FOOD:** A full menu will be offered at reasonable prices throughout the meet.
- MEET CONDUCT:** It is expected that each club will be responsible for the conduct of their swimmers. If in the opinion of the Meet Director, a swimmer's conduct is harmful to others or property, the swimmer will be asked to leave the meet. **Only coaches, swimmers, meet officials, and meet workers will be allowed on deck.**
