**Location:** Wauwatosa West High School

**Facility:** Six lane 25 yard pool with anti-turbulence lane guides, backstroke flags and 18" blocks. Pool depth is 3.5 ft. to 5 ft. Starting blocks are at the five feet end. Colorado timing system with two manual watches as back-up.

**Time Schedule:** AM Session: Warm-ups 7 AM- 8 AM.  
**Meet Starts 8:05 AM**  
PM Session: Warm-ups start immediately after morning session but not before 11AM.

**Warm-ups:** The first half hour of warm-ups will be general warm-ups only. The second half hour shall be for one-way sprints in lanes 4-6.

**Rules:** Official 2005 Short Course USS rule shall prevail for this meet. Swimmers must be registered Wisconsin USS swimmers. Out-of-state swimmers must be prepared to show their USS card.

**Format:** Pre-seeded events with staging by the Clerk of Course. All events will be timed finals.

**Entries:** Swimmers may compete in four individual events plus relays. Send entries to meet director no later than **January 7, 2005**. Send no seed Cards. Computer from the Official Individual and Relay Entry Forms will print seed cards. Print or Type entry forms clearly and accurately.  
This meet will be run using Hytek Meet Manager.  
Any teams wishing to submit their entries via commlink disk are encouraged to do so. Please mail a hard copy of your entry.  
Entry fees are \$2.00 per swim, \$2.00 Splash fee per swimmer and \$8.00 per Relay. Make checks payable to: **TOSA AQUATIC CLUB**.

Deck entries will be allowed subject to Meet Director approval. Entries will be limited to open lanes only; Events will not be re-seeded. Deck entries will be \$3.00 per swim and \$10.00 per relay

**Age & Class:** Age as of January 15, 2005 shall determine age group.

**Adaptive Swimmers:** Please inform officials and meet director of any disabled swimmers.

**Division:** Individual Events: A-BB+B-C for 10 & U, 11-12,13-14. 8&U age groups and Seniors will be one class with no cut-off times.  
Relay Events: All Relays will swim A-BB-B-C with Seniors,13 and 14 year olds swimming as one relay group.

**Awards:** Individual events: Custom medals for 1st -3rd place, ribbons 4th - 10th place. Achiever medals for B-C swimmers achieving A or BB times. Achiever awards will be of equal or greater value to the first place medals.  
Relays: Ribbons for 1st - 6th place. T-shirts will be awarded to swimmers establishing new Meet Records. Heat Winner Ribbons will also be given.

**Relays:** Coaches must have swimmers first and last names, ages, and Meet I.D. Number on the back of the seed cards. Relay teams will hand the seed cards to their timers when reporting to the blocks.

**Concessions:** Excellent food will be available at reasonable prices in the school snack bar/cafeteria. NO FOOD OR BEVERAGES WILL BE ALLOWED OUTSIDE OF THE CAFETERIA.

**Admissions:** \$2.00 admission charge for all spectators. Children under 12 have free entry. Heat sheets will be available for \$3.00

**Final Results:** Each team will receive a copy in the mail within one week after the event. Individuals may order a copy at the admissions table for \$3.00.
