WARM-UPS:	The first 30 minutes of each warm-up session is circle swimming only, no diving from the starting blocks. The next 30 minutes: Lanes 2,3,4, and 5 sprints (one directional swimming from starting end only, diving from the blocks permitted). Lanes 1 and 6 circle swimming. Meet Marshals will be on deck during the entire warm-up, with authority to recommend disqualification from individual events.			
ENTRIES:	Completed entry forms, signed waiver, and fees must be received by <b>Wednesday, May 1, 2002</b> . Preferred method of entry is by diskette in HY- TEK COMMLINK format. Diskettes MUST be accompanied by a hard-copy listing. Current USS ID number MUST be included on the entry form. All deck entries must be able to prove USS membership. Out of state swimmers must show their current USS card prior to swimming.
