relays will start in the water.

TIMING: <u>Colorado Timing System</u> with horn start, backup button, and manual stop

watches, using two timers per lane. All events will be timed finals.

OFFICIAL RULES: 2008 United States Swimming and Wisconsin Swimming Rules shall govern this

meet.

RELAYS: First and last names of competing swimmers and order of swimming must be listed

on the relay card, along with age, prior to swimming the relay.

WARM-UPS: The first 30 minutes of each warm-up session is circle swimming only, no diving

from the starting blocks. The next 30 minutes: Lanes 2, 3, 4, and 5 will be for sprints (one directional swimming from the starting end only, diving from the blocks permitted); Lanes 1 and 6 will be for circle swimming. Sit and Slide entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition. Meet Marshals will be on deck during the entire warm-up with the authority to recommend disqualification from individual

events.

ENTRIES: Seed times may be submitted in <u>YARD</u> or <u>METER</u> times. Completed entry forms, signed waiver, and fees must be received by **Friday**, **April 25**, **2008**. Preferred

method of entry is by e-mail in HY-TEK COMMLINK format. If sending a diskette, it MUST be accompanied by a hard-copy listing of entries. Current USA-S ID number MUST be included on the entry form. If e-mailing entries, hard copy, waiver and fees must be received by Tuesday, April 29, 2008. All deck entries must be able to prove USA-S membership. Out of state swimmers must

show their current USA-S card prior to swimming.

BE AT THE BLOCKS AT THE START OF HIS/HER EVENT. Staging assistance

will be provided for 8&U swimmers.

available at the admission table. Coaches and Club Officials desiring to be on deck

will be required to display proof of current USA-S membership at all times.
