**Times:** General Warm-up 9:00am. Meet starts at 10:05

**Facility:** An 8 Lane 25 yard pool with starting depth of 7 feet and a turn depth of 3 and half feet. Non-turbulent lane markers, backstroke flags. Regulation height starting blocks (30") and ample viewing area for swimmers and spectators (seats 400)

**Timing System:** Colorado System 5. Full Matrix LED displays with AquaGrip Touchpads and Infinity Start System and 1 button plus 2 watches as back up. All events are time finals.

**Warm-ups:** First 30 minutes – circle swim all lanes  
Next 30 minutes – Lanes 3,4,5 Dive/Sprints  
Lanes 1, 8 for 8 & Under only  
Lanes 2, 6, 7 circle swim

Failure to follow warm-up guidelines may result in disqualification from the next individual event

**Rules:** Official 2001 Short Course USA Swimming Rules shall prevail for this meet. Swimmers must be registered WISCONSIN USA Swimming swimmers. Swimmers' age is as of May 20, 2001. Relays: first and last names of competing swimmers and order of swimming must be listed on the back of the card along with age, prior to swimming the relay.

**Entries:** Completed entry forms, signed waiver, and fees must be received by **Wednesday, May 16, 2001**. Preferred method of entry is by diskette in Hy-Tek CommLink format. Diskettes **MUST** be accompanied by a hard-copy listing. Current USAS ID number **MUST** be included on the entry form. All deck entries must be able to prove USAS membership. Out of state swimmers must show their current USAS card prior to swimming.

**Entry Limit:** Only the first 800 individual entries will be accepted. Entries not accepted will be notified by phone as soon as possible. Swimmers are limited to four(4) individual events plus two(2) relays.

**Entry Fee:** Individual events: \$3.00  
Relays: \$8.00  
Splash fee: \$1.25

**Awards:** Awards for relay events will consist of ribbons for **1<sup>st</sup>-6<sup>th</sup> places**. Awards for individual events will consist of medals for **1<sup>st</sup>-3<sup>rd</sup> places** and ribbons for 4<sup>th</sup>-12<sup>th</sup> place. Heat winners for 6 & Under, 8 & Under and 10 & Under events will receive ribbons. Individual swimmers must claim their own awards. Awards will not be mailed

**Adaptive**

**Swimmers:** Any coach of a swimmers(s) with special needs must notify the head official of those needs at the beginning of the warm-ups.

**Seeding:** The meet will be pre-seeded. It is the swimmer's responsibility to be at the starting blocks at the start of his/her race. Staging assistant will be provided for 6 & under and 8 & under events.

**Final Results:** One copy of the meet result will be sent to all participating clubs. Additional copies may be ordered at \$5.00 per copy.

**Deck seeding:** Deck seeding will be allowed only to the limit of filling partially filled heats. A \$5.00 charge per event will be assessed for deck seeding. Deck seeding will close at 9:45am. Swimmers unable to prove USAS membership will be charged a deck-registration fee of \$47.00.

**Admission:** \$5.00, which includes heat sheet. No charge for children under 12 accompanied by adult. Coaches' packets will be available at the admission table. Coaches and Club Officials desiring to be on deck will be required to display proof of current USAS membership at all times.

**Concessions:** Delicious hot and cold food and drink will be available at reasonable prices in the Monona Grove Cafeteria.

**Meet Conduct:** Each team is responsible for the conduct of its swimmers. The meet director, at his discretion, shall remove from competition any swimmer who behaves in a disruptive or disorderly manner.
