Date	Saturday, January 19, 2002
Location`	Riverside Middle School, 106 Hall St., Watertown, WI
Pool	Indoor 25 yard pool with six lanes. Pool minimum depth is 3 6 . Starting block height is 18 .
Timing	Colorado electronic timing system with touch pads and manual back-up timing buttons and horn start. Each lane will have two timers with electronic stopwatches. All events will be timed finals.
Schedule	Meet will start at 9:05am Warm-ups for the AM session will be from 8:00 am - 9:00 am. 8:00 - 8:30am Circle swim all lanes. 8:30 - 9:00 am Circle swim lanes 1 & 6. Push/Pace 50 s lanes 2 & 5. One way sprints lanes 3 & 4. This procedure will be repeated for the afternoon session. Warm-ups for the PM session will not begin before 11:00 am. The diving well will be open at the referee s discretion. Coaches must be present to supervise their own swimmers in the diving well. No diving at any time.
Meet Format	Clerk of Course will be staging 8&U swimmers near the starting blocks. All other swimmers must be at the starting blocks at the start of their events.
Rules	2002 Short Course rules will apply. All swimmers must be USS registered. All out of state swimmers must bring their USS card to the meet. Age as of January 19, 2002. Deck entries will be allowed into open lanes only and will close 30 minutes prior to the session start. Swimmers not reporting to the blocks at the start of their event will be scratched.

Entry Limits	The first 1200 swims will be accepted. Swimmers may compete in 4 individual events and 2 relays events.
Entry Fees	\$3.00 per individual event and a \$1.25 splash fee per swimmer. \$8.00 per relay event. Fees are not refundable unless the meet is full.

Coaches Packs Coaches packs will be held for pick up in the pool office. A current USS Coaches membership card will be required to receive each pack.

Awards: Commemorative color mylar medals for each participating swimmer will be awarded.  
Ribbons for individual events places 1-6.  
6&U will swim with, but be awarded separately from 8&U swimmers in individual events.  
Ribbons for individual heat winners.  
Ribbons for relay events places 1-3.

Admissions Admission for persons 12 and over will be \$2.00. Heat sheets will be available for \$2.00.
