Pool:	Eight (8) lanes, 25-yard pool with non-turbulent lane markers, backstroke flags, and 30" blocks. Pool depth is 3.5 ft. at its shallow end and 9 ft. at its deepest end. Ample parking available in the high school parking lot and seating in the pool area. The starting block pool depth is 9 ft. All 100 Yd. Relay starts conducted at shallow end of pool must be in water starts.
Timing:	<u>Colorado electronic timing system</u> with touch pads and manual back-up timing buttons and horn start. Each lane will have two timers with electronic stopwatches. All events will be timed finals.
Meet Format:	Clerk of Course will be staging 8&U swimmers near the starting blocks. All other swimmers must be at the starting blocks at the start of their events.
Deck Seeding:	Deck seeding will be allowed only to the limit of filling partially filled heats. A \$5.00 charge per event will be assessed for deck seeding. Deck seeding will close at 8:15 AM for the AM Session and 15 minutes before the PM Session starts. Swimmers unable to prove USS membership will be charged a deck-registration fee of \$60.
Rules:	2007 USS and Wisconsin Swimming Rules shall govern this meet. All swimmers must be USS registered. All out of state swimmers must bring their USS card to the meet. Swimmers not reporting to the blocks at the start of their event will be scratched. Relays: First and last names of competing swimmers and order of swimming must be listed on relay card along with age, prior to swimming the relay. No Recall Starts.
