Facility: Eight or ten lane, 25 yard pool. Eight lane pool configuration: pool depth is 13 feet at the start end and

5' 10" feet at bulkhead (turn end).

Blocks are 30 inches high. The pool features a 9 ½ by 13 foot full color, digital display scoreboard.

Concessions will be available. No food or beverage is allowed in the pool area.

Classification: Silver Meet Time Standards, Wisconsin LSC dictated.

Rules & Eligibility: 2006 USA and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered with USA

Swimming.

Qualification Procedure:

Swimmers must have achieved the minimum time standard for all the events entered and CANNOT swim an event if the State qualifying time standard has been met. Please see

Silver Meet time standards posted on the Wisconsin Swimming website at

www.wisconsinswimming.org

If swimmers age-up after the Silver Meet and do not currently have State Qualifying Times for the next age-group they will enter, swimmers will be allowed to swim the event in their current age-group at the Silver Meet (regardless if they exceed the Silver Meet time standards). Please indicate this on the hardcopy you submit to the host clubs.

Swimmers are not allowed to "swim-up" if they currently have the Silver Meet qualifying time for the higher age-group they wish to enter. Swimmers choosing to "swim-up" must be attempting to achieve a WI LSC State qualifying time in that event and in their

age-group.

Schedule: All warm-up sessions and meet start times will be determined after entries are received. The timeline

will be posted on our website, <u>www.waukeshaexpress.org</u>, as soon as it is available.

Warm-ups: General warm-ups/circle swimming in all lanes for each warm-up session. Push-pace and sprint lines

will be opened and closed as necessary by the Meet Director and Meet Marshals.

Entry limit: 7 events total for the meet (no more than 5 on any one day).

Relays: Relays will not be contested.

Entry Deadline: **Tuesday, July 11, 2006**.

Any additional qualifiers can be added on July 17th if they qualify at a meet on the weekend of July 14 16, 2006. Entries will only be accepted for new qualifiers (no other changes will be allowed at that

time), and the information must be e-mailed to Laurie Carlson by noon on July 17th, to

laurie@waukeshaexpress.org. The swimmer's name, USS number, event number and seed time must be

included in the e-mail.

Entry Fees: \$4.00 per event

\$3.00 WI LSC splash fee per swimmer.

Deck Seeding: Deck entries will be accepted in open lanes only. Swimmers must already be entered in the meet and

meet the qualifying time standards (printed meet results must be provided proving the time standard).

Deck Registrations: Deck registrations will not be accepted.

Non-Conforming

Times:

DO NOT CONVERT. Swimmers must be entered at their best time. All courses will be used. Non-conforming times will be seeded after SCY times. The order used for seeing will be SCY-SCM-LCM.

Proof of Time: Any swimmer that does not meet the qualifying time standard must prove their time by the end of the

session in which they swim. Failure to not prove a time will result in a \$50 fine.

Timing System: Colorado System 6 with aqua grip touchpads.

Adaptive Swimmers: Please indicate on the entries form any special needs for those athletes requiring assistance. If a

swimmer thinks s/he may qualify as an adaptive swimmer please contact the Age-Group or Senior Chair for time standards. Also, please inform the Head Official of those needs prior to the start of the meet.

Awards: Ribbons: $1^{st} - 16^{th}$ place

Any awards not picked up during the course of the meet will be bagged and either handed out at

the 12 & Under Wisconsin LCM State Championships (July 28-30, 2006), the 13 & Over

Wisconsin LCM State Championships (August 4-6, 2006), or mailed.

Coaches: Meet packets can be picked up in the team mailboxes which will be located outside of the pool office.

All outstanding entry fees must be paid when picking up the meet packet. There will be a brief coaches meeting before the start of each day's meet. Meeting location and time will be announced during warm-

ups.

Scoring: This meet is not scored.

Officials: TBD

Meet Conduct: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet

Director or Meet Marshal, is harmful to others or to other's property will be required to leave the competition. Please sit in the designated areas for teams. All swimmers must keep their swim bags in the team seating areas. All spectators seating is at the south side of the pool. In accordance with

USA Swimming rules, NO SPECTATORS ARE ALLOWED ON THE POOL DECK.

Time Trials

WI Sanction #2006-082WI

Time Trials are available only to those swimmers entered in the Silver Meet.

Times: Time Trials will be offered Saturday and Sunday and/or as time permits and at the discretion of the Meet

Director as per LSC mandate.

Events: See meet order of events listing.

Fees: \$5.00 for individual events.

Registration: At the Meet Management table located outside of the pool office. Entries will be accepted during all

sessions, up until 30 minutes prior to the end of the Senior session (swimmers in the last event of the day

have 10 minutes after the end of that event to sign-up for Time Trials).

Procedure: Swimmer will sign-up for an event at the Meet Management table. Swimmer will fill out a seed card at

the table – swimmer's name, age, team, event name, and seedtime. Seed card and event fee must be turned into the Meet Management table before the registration deadline. A meeting for all Time Trial participants and timers will be held prior to the start of Time Trials. Cards with heat and lane assignments will be handed out during the meeting. It is the swimmer's responsibility to be ready to swim when her/his event, name, and lane number is called. The Referee will not hold the start of the

event, waiting for a swimmer (or timer) to show. An announcement will be made that Time Trials are beginning and swimmers and timers should report to the meeting immediately. ALL Time Trial cards

(whether or not a swimmer swims a desired time) MUST be turned in at the end of each heat.

Meet Host Provides: Officials, Timing System Operator, and Meet Management.

Swimmer Provides: Two (2) timers, two (2) watches, and counter (if needed).

Reminders: The maximum number of individual events in one day is three (5) and includes Time Trials (USA

102.2.5 and 102.2.6). This means that a swimmer may swim 5 individual events total, including a

combination of:

1) only Time Trials

2) combined Time Trials and meet events

3) only meet events

Time Trials will begin promptly. It is the responsibility of the swimmer to be at the blocks, complete

with her/his two timers (and two watches), ready to swim.

Timers must turn in their cards whether or not a swimmer achieves a desired cut time.
