

# 2008 Wisconsin LSC Silver State Meet

## *Hosted by Waukesha Express Swim Team*

### *WI Sanction #2008-156WI*

- Date: July 18 – 20, 2008
- Location: Waukesha South High School  
401 E. Roberta  
Waukesha, WI 53186
- Facility: Eight or ten lane, 25 yard pool. Pool depth is 13 feet at the start end and 5' 10" feet at bulkhead (turn end). Blocks are 30 inches high. The pool features a 9 ½ by 13 foot full color, digital display scoreboard. Concessions will be available. No food or beverage is allowed in the pool area.
- Classification: Silver Meet Time Standards, Wisconsin LSC dictated.
- Rules & Eligibility: 2008 USA and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered with USA Swimming.

#### **Qualification**

##### **Procedure:**

There are no qualifying times for this meet. Swimmers may enter and compete in any event in which they do not have the state qualifying time. The time standards are listed at [www.wisconsinswimming.org](http://www.wisconsinswimming.org). If a swimmer makes the qualifying time after the meet entries have been submitted, they will be allowed to compete in that event at this meet and the State meet.

If a swimmer, age 14 or under, has achieved the state cut in a given race, they can enter the Senior age group for that event, if and only if, they have NOT achieved the state cut in the Senior age group. Any swimmer that has already achieved the Senior cut is not allowed to swim that race.

- Schedule: All warm-up sessions and meet start times will be determined after entries are received. The timeline will be posted on our website, [www.waukeshaexpress.org](http://www.waukeshaexpress.org), as soon as it is available.
- Warm-ups: General warm-ups/circle swimming in all lanes for each warm-up session. Push-pace and sprint lines will be opened and closed as necessary by the Meet Director and Meet Marshals. Sit and slide entry will be enforced during general warm-ups.
- Entry limit: 7 events total for the meet (no more than 5 on any one day).
- Relays: Relays will not be contested.
- Entry Deadline: **Tuesday, July 8, 2008**

- Entry Fees: \$4.00 per event  
\$3.00 WI LSC splash fee per swimmer.
- Deck Seeding: Deck entries will be accepted in open lanes only. Deck entries are \$8.00 per event.
- Non-Conforming Times: **DO NOT CONVERT.** Swimmers must be entered at their best time. All courses will be used. Non-conforming times will be seeded after SCY times. The order used for seeding will be SCY-SCM-LCM.
- Timing System: Colorado System 6 timing system with aqua grip touch pads.

Disabled Swimmers: Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the Head Official of those needs prior to the start of the meet.

Awards: 1<sup>st</sup> – 16<sup>th</sup> place ribbons will be awarded  
High Point: 1 – 3<sup>rd</sup> place in each age group  
Team Awards: 1 – 3<sup>rd</sup> place  
Any awards not picked up during the course of the meet will be bagged and either handed out at the 12 & Under Wisconsin LCM State Championships and the 13 & Over Wisconsin LCM State Championships.

Coaches: All coaches must pick up their coach's packets in person and must show their coach's card. If a coach does not present an USA Swimming Coach's card, they will not be allowed on deck and the swimmers for the team will be assigned to an USA Swimming certified coach for warm-ups.

Scoring: This meet is not scored.

Officials: Meet Referee: John Borja

Meet Conduct: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshal, is harmful to others or to other's property will be required to leave the competition. Please sit in the designated areas for teams. All swimmers must keep their swim bags in the team seating areas. All spectators seating is at the south side of the pool. In accordance with USA Swimming rules, **NO SPECTATORS ARE ALLOWED ON THE POOL DECK.**  
In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

## *Time Trials*

### *WI Sanction #2008-157WI*

- Times:** Time Trials will be offered Saturday and Sunday and/or as time permits and at the discretion of the Meet Director as per LSC mandate.
- Events:** See meet order of events listing.
- Fees:** \$8.00/event, no relays will be offered.
- Registration:** Entries will be accepted during all sessions, through Sunday morning. Meet management will announce deadline for time trials, which will be early Sunday afternoon. If a swimmer is not signed up for the Silver State meet they must be able to prove they are registered with USA Swimming for 2008.
- Procedure:** Swimmer will fill out a seed card at the table – swimmer's name, age, team, event name, and seedtime. Seed card and event fee must be turned into the Meet Management table before the registration deadline. A meeting for all Time Trial participants and timers will be held prior to the start of Time Trials. Cards with heat and lane assignments will be handed out during the meeting. It is the swimmer's responsibility to be ready to swim when her/his event, name, and lane number is called. The Referee will not hold the start of the event, waiting for a swimmer (or timer) to show. An announcement will be made that Time Trials are beginning and swimmers and timers should report to the meeting immediately. ALL Time Trial cards (whether or not a swimmer swims a desired time) MUST be turned in at the end of each heat.
- Meet Host Provides:** Officials, Timing System Operator, and Meet Management.
- Swimmer Provides:** Two (2) timers, two (2) watches, and counter (if needed).
- Reminders:** The maximum number of individual events in one day is five (5) and includes Time Trials (USA 102.2.5 and 102.2.6). This means that a swimmer may swim 5 individual events total, including a combination of:
- 1) only Time Trials
  - 2) combined Time Trials and meet events
  - or
  - 3) only meet events
- Time Trials will begin promptly. It is the responsibility of the swimmer to be at the blocks, complete with her/his two timers (and two watches), ready to swim.
- Timers must turn in their cards whether or not a swimmer achieves a desired cut time.
